## 1. CALL TO ORDER/INTRODUCTIONS:

**3. MODIFICATIONS AND APPROVAL OF AGENDA.** Approved without modification.

#### 4. APPROVAL OF THE MINUTES OF 11-02-20, 11-24-20 – Continued

**5. PARKS FOR ALL (Action Item) - 30 min.** (Carolyn Chase, Parks and Recreation Coalition) Presented a response to the draft Parks Master Plan and Recreation Element which has been continued by the City Council. The Parks and Recreation Coalition is requesting support to the Mayor and Council for improvements in the PMP and direction to staff to work with CPGs, RAGs, and PARC for input.

#### **Board Comment:**

Main concerns included:

- Strong support for presenter's contention that land acquisition be a main consideration in parks and PMP, even to the extent of going back to the old standard of 2.8 acres per 1,000 people in the General Plan
- The point system that awards certain amenities (i.e. swing set) same value as one acre of land
- Allocation of money/funding needs to be based on equity
- The PMP was rushed through the process without proper advance notice and review by the planning groups
- Need for Planning Department staff to reach out to previously neglected planning groups, recreation councils for their input before moving forward.
- No net loss of park acreage was advocated
- Concern over commercialization of parks (i.e. food trucks) was expressed

#### **Motion:**

SE moved to approve Park and Recreation Council (PARC) recommendations for how money is to be allocated based on equity. MM moved to amend motion to approve PARC recommendations to allow existing projects in the FBA to be completed before they are allocated into a City-wide FBA pot, RB seconded. Ayes: CMR, CH, COL, EAS, KT, LJ, LV, MM, NH, OB, PB, RB, RP, SP/LH, SR, TP, UN. Nays: DWNTN, UT. Abstain: GH, MW, MB, SE. Motion passed 17-2-4.

6. GUIDANCE FOR CPG ELECTIONS. (Action Item) - 30 min. (Tait Galloway, City of San Diego Planning Department) presented guidance information for CPG elections. Galloway said CPGs are encouraged to use multiple election methods to conduct their March 2021 elections that minimize in-person interactions or postpone their March 2021 elections. CPGs can utilize one or more of the following methods: mail-in ballots, ballot drop off location(s) and online voting. The CPC will

discuss alternatives and may develop further recommendations.

### **Board Comment**

Main Concerns included:

- Whether CPG's can hold combination of in-person and mail in ballot. Staff responded in affirmative
- Whether CPG's cannot hold elections in 2021 due to COVID restrictions and wait until 2022. Staff responded in affirmative
- How to ensure confidentiality with all forms of voting
- Other concerns: monitoring of ballot drop off boxes, postmarking of ballots to ensure compliance with deadlines, options for announcing election results

7. ELECTRICITY AND GAS SUPPLY FRANCHISE AGREEMENTS (Action Item) - 30

**min.** (Eduardo Savigliano, Torrey Pines CPB) reported that the City of San Diego will be holding Electricity and Gas supply Franchise Agreements Public meetings January 28 and Feb 25, 2021. The CPC will discuss alternatives and may develop recommendations.

The CPC was to discuss the report and its proposed recommendations, and possibly develop further recommendations for CPGs.
