Andrea Demich will describe the next iteration of the Capital Improvement Program (CIP) refresh. As in past years, CPGs will provide input on their community needs for capital projects. These include requests for major

installations or renovations, but not maintenance or operations. Input will probably be due in August. There will be a revamped web application for entering data.

ITEM #7 – 8:00 FAITH COMMUNITY HOUSING AGENDA– Information Item

Monica Ball, Uplift, will describe how the faith community is offering a third option in the Housing Crisis conversation. There are many parcels in the City with a "religious use" land use designation, which might accommodate residential units

without rezoning. The purpose of the presentation is to inform CPG leaders about opportunities for quality of life improvements in their neighborhoods, offer to address CPGs and host information meetings, and to solicit potential partners and seek guidance from CPGs on areas that may have under-utilized parking lots, land, or buildings.
