Until further notice, Council Staff Docket Briefing meetings will be held virtually on Zoom Webinar pursuant to the provisions of California Government Code section 54953(e), added by Assembly Bill 361, which allows the City to use teleconferencing and to provide the public an opportunity to address the City Council via a call-in option or an internet-based service option, during a proclaimed state of emergency when measures to promote social distancing are in effect or the City Council has determined meeting in person would present imminent risks to the health or safety of attendees.

This meeting allows staff from City and independent departments to brief Council offices on certain items anticipated to appear on the Monday January 31 and Tuesday February 1, 2022 agendas of the San Diego City Council and/or Housing Authority.
