APRIL 5, 2017 – PUBLIC SAFETY & LIVABLE NEIGHBORHOODS (PSLN) COUNCIL COMMITTEE

On April 5, 2016 the PSLN Committee forwarded the Draft FY 2018 AAP and Substantial Amendment to the full City Council with a recommendation to approve.

Robert McNamara (Submitted a speaker's slip in favor)

- Mr. McNamara stated the importance of the CDBG program and all the benefits to the community it brings.

Raymond Bernal (Submitted a speaker's slip in favor)

- Mr. Bernal is looking forward to the proposed upgrades to Memorial Park.

Andrea Sorce (Submitted a speaker's slip in favor)

- Ms. Sorce, representing International Rescue Committee, was thankful for being awarded CDBG funding and appreciates the impact the program has throughout the community.

Anchi Mei (Submitted a speaker's slip in favor)

Staff response: The item was created for rehabbing and acquiring a homeless facility and staff is currently looking at rehabbing the Neil Good Day Center; another possibility is supporting the City Attorney's office in further implementing the SMART program. For the Promise Zone, staff is looking at different options to incorporate the Promise Zone into scoring applications.

Councilmember Chris Cate

- Mr. Cate thanked the CPAB on the hard work in evaluating the proposals.
- Mr. Cate asked how agencies would be affected by the potential federal budget cuts.

Staff response: Agencies are aware of the potential reductions but staff and the agencies will negotiate the specific terms during the contract execution phase.

Councilmember Chris Ward

- Mr. Ward thanked staff and the CPAB in their efforts in this process.
- Mr. Ward asked what the process is in allocating funds for homeless efforts. Mr. Ward also asked if the intent to use funding is for rehabbing the old central library into a homeless services provider.

Staff response: Staff will work with the San Diego Housing Commission and their approved contractor and present to City Council. At this time, CDBG funding would not be allocated to the old central library for homeless services.

Councilmember Barbara Bry

- Ms. Bry thanked staff and the CPAB in their efforts in this process.

Councilmember Scott Sherman

- Mr. Sherman asked if staff needs 20% administration fee and how many new programs are receiving funding as compared to previous years.

Staff response: The 20% cap is mandated by HUD and the Community Development Division is looking at hiring more staff to assist in managing the increase in projects. The Admin Cap also includes the nonprofit academy, plans and studies, consultants, and the ED grants management system. With the additional resources available, the Community Development Division was able to add 7 new programs ranging from workforce development programs to a new sustainability challenge grant.

Council president Myrtle Cole

- Ms. Cole is thankful for the Bay Terraces Senior Community Center and that Council District 4 has been waiting 25 years for a senior center.

Item was approved unanimously 8-0, with one City Council member absent.


