# FY 2022 Budget Development and FY 2021 Budget Monitoring Key Dates

### **OVERVIEW**

The draft FY 2022 Budget Development and FY 2021 Budget Monitoring calendar ("Key Dates") are prepared with input from the Office of the IBA, the Department of Finance, Engineering and Capital Projects, Public Utilities, Human Resources, the Budget and Government Efficiency Committee Consultant, the Active Transportation and Infrastructure Committee Consultant, the Office of the City Attorney, and the Director of Legislative Affairs. The Key Dates are based on timelines required by the City Charter as well as those established by the previous fiscal year's legislative calendar. The Key Dates include planned release dates of budget-related reports for both the operating and Capital Improvements Program (CIP) budgets, and their corresponding presentations to Council committees and to the full City Council.

The Office of the IBA believes that the proposed Key Dates for the development and adoption of the FY 2022 budget provide numerous opportunities for input from the public and for City Council review and deliberation, while complying with all City Charter requirements. We recommend that the Budget and Government Efficiency Committee review and approve the calendar and forward it to the City Council for consideration.

Tuesday, June 15, 2021	City Clerk to transmit resolution to Mayor within forty-eight hours of passage.
Wednesday, June 16, 2021	Mayor's veto period begins (Mayor's veto period is five business days after receipt of budget resolution from the City Clerk).
	Release of FY 2022 Appropriation Ordinance (text only).
Tuesday, June 22, 2021	Mayor's veto period ends. If appropriate, Council has five business days to override Mayor's veto.
Wednesday, June 23, 2021	Budget and Government Efficiency Committee reviews FY 2022 Appropriation Ordinance (text only).
Tuesday, June 29, 2021	City Council consideration and adoption of the FY 2022 Appropriation Ordinance. Per the City Charter, the adoption of the Appropriation Ordinance is required no later than June 30. Additionally, City Council considers and adopts Tax Rate Ordinance (August 31 deadline) and Gann Limit (June 30 deadline).
	If applicable, Council's time period to override a Mayor's veto ends.
Wednesday, July 21, 2021	Budget and Government Efficiency Committee reviews FY 2022 Statement of Budgetary Principles.
Monday, August 2, 2021	City Council consideration and adoption of the FY 2022 Statement of Budgetary Principles.
