1. <u>CALL TO ORDER</u>: Chair Joe La Cava called the meeting to order at 7:00 pm and proceeded with roll call.

## 2. <u>NON-AGENDA PUBLIC COMMENT</u>:

Guy Preuss, Skyline/Paradise Hills, reported that the City is proposing a Small Lot Subdivision Ordinance.

Jay Shumaker, Peninsula, requested that a presentation on form-based codes be an item at a CPC meeting.

#### 3. MODIFICATIONS AND APPROVAL OF AGENDA:

Mathew Paredes, San Ysidro, moved to approve the agenda. Seconded by Vicki Granowitz, North Park. Motion passed unanimously.

### 4. APPROVAL OF THE MINUTES OF NOVEMBER 27, 2012:

Jim Varnadore, City Heights, moved to approve the minutes. Seconded by Matthew Paredes, San Ysidro. Motion passed 19-0-6. Abstentions: Miramar Ranch North, Centre City, Mission Valley, Carmel Valley, Mission Beach, Peninsula.

## NEIGHORHOOD PARKING PROTECTION PROPOSAL & PILOT: Possible Action Item

Councilmember Kevin Faulconer and Matt Awbrey, Council District 2 Representative, provided an overview of the Neighborhood Parking Protection Proposal and Pilot Program

- 1). Motion by Debbie Watkins, Mission Beach, to support the LU&H recommendation to implement a pilot program in the coastal areas, with an evaluation after one year to determine whether to adopt the program city-wide. Motion passed by a vote of 17-8-1. 8 Against: Uptown, Skyline/Paradise Hills, City Heights, Otay Mesa, Rancho Bernardo, Eastern, Kensington/Talmadge and Mission Valley. 1 Abstention: La Jolla.
- 2). Motion by Jim Varnadore, City Heights, to prohibit overnight parking of large commercial vehicles on residential and commercial streets. Seconded by Vicki Granowitz, North Park. Motion passed by a vote of 20-2-3. 2 Against: Navajo and Otay Mesa. 3 Abstentions: Mission Beach, Pacific Beach and La Jolla.

Motion by Jim Varnadore, City Heights, that CPC has no objection to phased fee implementation with the understanding that full cost recovery may be achieved sooner. Seconded by David Moty, Kensington/Talmadge. Motion passed by a vote of 21-1-2. 1 Against: Serra Mesa. 2 Abstentions: Peninsula and La Jolla
