1. <u>CALL TO ORDER</u>: Chair Joe La Cava called the meeting to order at 7:00 pm and proceeded with roll call.

2. <u>NON-AGENDA PUBLIC COMMENT</u>:

Stacy Ingnell, Downtown Partnership, spoke about Our Downtown Vision Plan.

3. MODIFICATIONS AND APPROVAL OF AGENDA:

4. <u>APPROVAL OF THE MINUTES OF FEBRUARY 26, 2013</u>:

Mayor Bob Filner provided an overview of his vision for neighborhoods, the role of community planning groups, and the removal of the Planning Division from DSD.

6. <u>COUNCILMEMBER MARK KERSEY</u>: Information Item

Councilmember Mark Kersey, Chair of Infrastructure Committee, discussed the Council's renewed focus on infrastructure and highlighted some of the topics being addressed by the Committee/.

7. CRAFT BEER IN INDUSTRIAL LANDS: Action Item

Russ Gibbon, Business Development Manager and Amanda lee, Senior Planner, requested that CPC provide a recommendation to the City Council regarding proposed amendments to the Land Development Code to allow for manufacturers of malt beverages or distilled spirits, of at least 12,000 square feet in size, to have an accessory restaurant or tasting room that is greater than 3,000 square feet in gross floor area.

Motion by Guy Preuss, Skyline/Paradise Hills to support the staff recommendations. Seconded by Melanie Nickel, North Bay. Motion Passed unanimously 28-0-1. 1 Abstention: La Jolla.
