Andrew Poat of the Greater San Diego Chamber of Commerce presented a proposed "top to bottom" reform of the City's infrastructure planning and funding processes. CPC will monitor this effort as it moves forward.

# 7. MODIFY 600-24 TO GAIN GREATER DIVERSITY OF VIEWPOINTS ON PLANNING REPORTS: Possible Action Item

Referral from the Economic Development & Strategies Council Committee based on input from Regulatory Relief Day held November 11, 2011, specifically, "Suggestion #27, Part 4: Rework the criteria for being a member of the Community Planning Groups to ensure diversity of viewpoint."

Motion by Jim Varnadore, City Heights, to authorize and direct the Chair of CPC to correspond with the Economic Development & Strategies Council Committee. CPC reviewed the proposal and believes there is sufficient diversity in the community planning system and changes are not needed to the Council Policies or bylaws. Seconded by Laura Riebau, Eastern Area. Motion passed 25-0-1. 1 Abstention La Jolla.
