**1.** <u>CALL TO ORDER</u>: Chair Joe La Cava called the meeting to order at 7:00 pm and proceeded with roll call.

### 2. <u>NON-AGENDA PUBLIC COMMENT</u>:

Andrew Keatts, Voice of San Diego reporter, introduced himself and how he has been covering land use issues. . Andrew asked for input on land use issues from the planning groups.

### 3. MODIFICATIONS AND APPROVAL OF AGENDA:

### 4. APPROVAL OF THE MINUTES OF MAY 28, 2013:

Mel Ingalls, Otay Mesa, moved to approve the minutes. Seconded by David Moty, Kensington/Talmadge. Motion passed 21-0-5. 5 Abstentions: Pacific Beach, Mission Beach, Normal Heights, Ocean Beach and La Jolla.

## 6. <u>NEIGHBORHOOD INPUT ON INFRASTRUCTURE NEEDS AND PRIORITIES-FY 2015:</u> Information Item

James Nagelvoort, Assistant Director, , and Marnell Gibson, Deputy Director, Engineering & Capital Projects lead a discussion to kick off the start of planning group process for gaining input on infrastructure need and priorities for FY 2015. Motion failed by a vote of 8-16-2. 8 in Favor: North Park, Mission Valley, Rancho Penasquitos, Southeastern, Navajo, University, Mission Beach and Eastern. 2 Abstentions: Pacific Beach and La Jolla.

Kenneth Malbrough, Encanto, motioned to form a General Ad Hoc Committee to address Council Policy 600-24.. Motion Passed 27-0-1. 1 Abstention: La Jolla.
