City Council Office District 6 Representative Denise Torres:

- 2. The San Diego City Council voted for a Resolution to declare Housing a Human Right on Monday, October 31st. - 3. We had an eventful groundbreaking for the Salk Neighborhood Park and Joint-Use Facility attended by the Mayor, Councilmember Cate, and the San Diego Unified School District administrators along with the school administrators and students at

- Jonas Salk Elementary School. Thank you to all that came and supported the event that day. We also thank everyone in advance for your continued support and patience as the construction is in progress.
- 4. Installation of new continental crosswalk and new limit line on the **north leg** (all other legs have existing continental crosswalks and advance limit lines) of Aderman Ave and Mira Mesa Blvd was completed.
- 5. A GID report was submitted for Aderman Ave for the turn on left traffic light that is non-working. Transportation is looking into the issue. More updates to follow.
- 6. City Council will be on legislative recess starting this week. And then resuming the week of November 14-17. Back to recess for the rest of November. Therefore, council meetings will resume December 5th.
