STAFF REPORTS:

City Council Office District 6 Representative Denise Torres:

1. Traffic Service Request Update: Proposed "STOP" sign on Scorpius Way and Taurus Place. The City Engineer evaluated the area and the intersection met the criteria to install a STOP sign along Scorpius Way facing northbound traffic. If there are no comments, city crew will proceed with the installation of the said STOP sign along Scorpius Way. - 2. Regarding trash and litter along Kearny Villa Rd and Miramar Rd, the City's contractor(s) will abate the subject areas the week of September 12, 2022 ahead of the MCAS Miramar Air Show. The scope will include clearing shoulders, medians, ramps and litter pick-up associated with the vegetation abatement along Miramar Rd and Kearny Villa Rd. The limits of the abatement will encompass Kearny Villa Rd from Miramar Rd to Hwy 52 and Miramar Rd from Hwy 805 to Hwy 15.
- 3. Budget Priorities are coming up. Councilmember Cate and the office are reviewing the budget memo policies for District 6. - 4. Crime prevention: Neighborhood Watch and block captain volunteer to assist CROs MM Tree Fund Update:

From Parks & Rec. City staff:

"We reached out to our friends over in DOF to pull the file for this item. We are hoping to receive a copy of the letter of support from the developer (sponsor) indicating that the tree fund could be used for all of the parks in the Mira Mesa area versus just Hage. They could not produce that document and we did not have a copy of that letter in our files. We are going to reach out to Joe and/or the developer to see if they have a copy of that letter.

In the meantime, an LSR was drafted for the CAO to seek guidance on how we can proceed forward. Salome is following up to make sure that was sent along with all of the attachments.

We will discuss some other options and are hoping to meet with [Denise Torres] and Joe Frichtel, possibly in the field. Please let [Steve Palle] know and we can set that up."

Denise Lamb reported on behalf of OCA Area Manager Bianca Padilla:

- 1. At Challenger JU, the DG on the walking path has been replenished
- 2. One of the GMWs, Nacho, has accepted an Out of Class Assignment as a Ground Maintenance Supervisor in the Downtown Area. He will be gone for about 4 weeks
- 3. Lopez Ridge has been sprayed for insects and Gil Johnson has been treated for insects and rodents.
- 4. The GMW is still working on the irrigation at Camino Ruiz NP. We are hoping to get the water back on soon
- 5. There was an issue with the restrooms at Westview NP, but the problem has been fixed.

- 1. Fall classes have started this week.
- 2. We are working hard to continue the maintenance work at our parks.

Recreation Center Director Denise Lamb reported:

- 1. The Fall Volleyball season is looking strong with 10 teams enrolled.

- 3. There seems to be an issue with the water fountains at a lot of the parks. There seems to be a backlog.
- 4. There has been irregular mowing at the fields. It is possibly a staffing issue.
- 5. There are a lot of issues at the Maddox playground. Working with management to assess and address the problems.
