## **WORKSHOP ITEMS -**

501c3 - Glenda Gates, Cybelle Thompson

- We need a statement to see if we owe anything from 2010 to 2016
- Taxes from 2021-2022 have not been filed. These will need to be filed for 501c3 to become current
- Does not think there will be any fees since it has not been active. No income has been coming in
- The name of the 501c3 is Mountain View Recreation Council. Per Cybelle Thompson the City would be okay with keeping that name since other recreational groups have been using the recreation council name
- The reason for having a current 501c3 is so that we can put any monetary donations in there for programs, celebrations and upgrades
- Officers will have to be nominated to run the 501c3
- Non-profit insurance might be needed
- The city will need a yearly financial statement of funds coming into the recreational group

Review Amend Bylaws - Lucero Cuarezma-Samano

- Article III:
  - ❖ Add: A nonprofit community service agency or organization open to the public within the designated geographic area shall be eligible to have one representative serve on the recreational group.
- Article IV:

- ❖ Add: All elected officers must reside or own property in the geographic area to hold an officer seat on Mountain View Community Recreational Group.
- ❖ Add: Elected officers at large shall serve one year term and may be eligible to serve three consecutive one-year terms.
- Article X
  - ❖ Change to 25 % of members to have a quorum
