<u>APPROVAL OF THE MINUTES – July, 2022:</u> Motion made Trevor Christenson/Sally Grigoriev to approve the minutes as presented. Motion passed unanimously.

<u>TREASURERS REPORT</u> – Ms. Grigoriev. A financial report was not sent to the Rancho Bernardo Community Recreation Group by the City. Becky Lowndes reported that as of July, 2022 (2 months ago) the Rancho Bernardo Community Recreation Group had \$232,433.84.

CHAIRPERSONS REPORT – **Ms. Kaufman**: Ms. Kaufman welcomed everyone and reminded them we run the meetings the same way as if in person. Residents will be given 3 minutes to speak on any action item prior to it being discussed by the Community Recreation Group. Once the Community Recreation Group begins discussion, in accordance to the City, there will be no further comments/questions from the audience. Residents reached out to Ms. Kaufman this past month in regard to: renting the gym, renting the gazebo, concerns trash cans are overflowing throughout the park, concerns regarding to field conditions. Ms. Kaufman informed everyone the RFP for the lawn bowling area expires 4 p.m. today. Finally, a resident called Ms. Kaufman to say while she was exercising her dog off leash on field 7, another off leash dog attacked her dog. She was reminded that dogs are to be kept on leash at all times on City property except when in an off leash dog park and to call our office to report the incident.

Becky Lowndes – Area Manager: Aztec is being contacted in regard to the field conditions. Work is scheduled

mid December through January.

**Eric McDonald** - Recreation Center Director. The center is working with a skeleton crew. The center's assistant director was promoted, and there are a lot of staffing challenges.

Landscape Concept Improvements includes: CURB RAMPS AT INTERSECTION - NEW SIDEWALKS - CHAIN LINK FENCING - PARKING LOT ADA SPACES - COMFORT STATION FLOOR - LANDSCAPE & IRRIGATION MODIFICATIONS-NEW SIDEWALKS - CHAIN LINK FENCING - PARKING LOT ADA SPACES - SITE FURNISHINGS - MULTI-USE PATH STRIPING - MULTI-USE PATH BOLLARDS - SHADE SHELTERS - SYNTHETIC TURF - LANDSCAPE & IRRIGATION MODIFICATIONS

Dog Park Concept includes: - (3) 8' X 20' 2-POST STEEL SHADE SHELTERS - 8'-10' WIDE STRIP OF SYNTHETIC TURF - HOSE BIB(S) - SHADE TREES.

Mr. Huwa explained there are environmental challenges to why there cannot be water fountains in each pen, including where the water drains to afterwards (i.e.: storm water).
