CALL TO ORDER

Darrel Madison called the meeting to order at 6:40 p.m.

APPROVAL OF THE MINUTES OF OCT.7TH, 2020

 Correction of Ranger's Report to show the Park Ranger as Steven Smith and not Cameron Engelhart was noted. Darrel Madison mentions the need to have an explanation of the Trunk Sewer Project origin as the 2016 Tecolote Creek spill of 6.8 million gallons of sewage. Eloise Battle moves to amend minutes to mention 2016 Trunk Sewer Project origin. David Harpster seconds. (MADISON) Do I have a MOTION to approve the minutes of October 7th, 2020, upon correction stated above. Eloise Battle moved to approve, and David Harpster seconded, (BATTLE/HARPSTER). Motion to amend minutes is approved. (MADISON) asked, all those in favor? All were in favor. All those opposed? Any abstentions? None. The notion to approve the minutes passes with all members voting in favor.

<u>CITY COUNCILMEMBERS' REPORT – District 2 Councilmember Staff Assistant Carrie Munson</u>

 Darrel will forward email from Carrie Munson from Clairemont Community Planning group regarding Council Campbell to discuss 2020 accomplishments and 2021 goals. Meeting is Dec. 18th 12pm 2020. Mention that Measure E passed.

- 1. Darrel noted someone built a bridge under Balboa Ave.
- 2. Darrel mentioned graffiti middle of Tecolote on bridge had been painted over but had been tagged again. Steve mentioned his team had painted over the graffiti and had purchased more paint to cover over new graffiti.
- 3. Clairemont Town Council recommended approval of the Tecolote Master Plan update.
- 4. Darrel noted Meetup has 452 members.
- 5. Audubon Bird Festival trips will be limited to 8 or fewer participants. Anitra will post on Meetup when more details are available.
- 6. Corey Stapellton will be giving a presentation on Path San Diego, homeless outreach.

STAFF / RANGER'S REPORT – Park Ranger Steven Smith

- 1. Steve stated that a new restoration area of almost 2 acres had been cleared in Tecolote Canyon. The rangers will be using a new app to record data at this site.
- 2. Steve mentioned this data will be used to apply for grants for additional restoration funding.
- 3. Erika mentioned that city biologist will be using Tecolote's revegetation efforts as a model for other city sites.
- 4. Green Friday event will be a self-guided interpretive hike on Battle trail, Darrel will post on Meetup and Erika will email volunteers.

- Anitra reported seeing large numbers of migrating Blue-Grey gnatcatchers.
