Subject: Commission on Police Practices' Recommendations for Public Safety & Livable Neighborhoods Committee Consideration Regarding the Implementation Ordinance

At our November 23, 2021 Commission on Police Practices (Commission) meeting, the Commission voted unanimously to share the Commission's recommendations regarding the Implementation Ordinance that will establish the Commission with the Public Safety and Livable Neighborhoods (PS&LN) Committee and then the full City Council for consideration.

The attached list of recommendations was compiled based on feedback and community input from months of public weekly meetings held by our Ad Hoc Transition Planning Committee. The recommendations were discussed and approved by the full Commission last week. Also attached is an updated draft transition planning timeline for the Commission. Please note that this draft timeline was previously shared with the City Council and is an evolving document for planning purposes only.

The Commission wishes to thank the members of this Committee and its outside counsel for considering and incorporating nationwide best practices and community-based recommendations into the draft Implementation Ordinance document.

The Commission respectfully requests an opportunity to receive and review the second draft of the Implementation Ordinance ten days prior to the Public Safety & Livable Neighborhoods Committee meeting where it will be considered.

The Commission believes strongly that public input and transparency is vital to the Commission being a trusted resource in the oversight of law enforcement. We look forward to continuing to work with you as the City finalizes the Implementation Ordinance and welcome the opportunity to discuss our recommendations further with you.
