## Background

In an effort to address the inequitable distribution of pollution and associated health effects in low-income communities and communities of color, the California Legislature passed and Governor Brown signed Senate Bill (SB) 1000 into law in 2016, requiring local governments to identify environmental justice communities (called “disadvantaged communities” in the law) in their jurisdictions and identify objectives and policies to address environmental justice in their General Plans. An additional requirement of SB 1000 is to encourage community participation in the planning process and civic decision-making processes more broadly.

There are many ways to think about environmental justice (EJ). The environmental justice survey that is discussed in this report was guided by the definition of environmental justice as “Fair treatment of people of all races, cultures, and incomes with respect to the development, adoption, implementation, and enforcement of environmental laws, regulations, and policies” (California Government Code Section 65040.12(c)). In other words, environmental justice means ensuring that people of all races, cultures, and incomes are equally and equitably valued, protected, and served by laws, regulations, and policies that impact the environment around us, including the laws, regulations, and policies about buildings and uses of land, transportation, parks and natural spaces, the urban landscape, and city services.

The City of San Diego will be working with its communities to update the environmental policies in the City’s General Plan through the development of an Environmental Justice Element, or chapter. The environmental justice survey was conducted online by the City’s Planning Department from late November 2020 through June 2021. It began the policy update process by providing background information about environmental justice and the General Plan, asking for community members’ thoughts on what issues the City’s environmental justice policies should prioritize, and asked for community members’ input on what environmental justice issues they experience in their neighborhood.

During the time period when the survey was administered and this summary report was written, “disadvantaged communities” had not yet been identified. A collaborative process between City planners and community members is underway to identify the focus areas for the City’s Environmental Justice Element. However, information from the California Office of Environmental Health Hazard Assessment’s CalEnviroScreen 3.0 tool, the City of San Diego Sustainability Department’s Climate Equity Index, and other demographic and income data has been utilized by Planning Department staff to preliminarily highlight certain community plan areas that include neighborhoods experiencing disproportionate pollution and low-income conditions. For the purposes of this report, these communities will be called “Preliminary Focus Areas” and they are (in alphabetical order): Barrio Logan, Downtown, Encanto Neighborhoods, Golden Hill, Kearny Mesa, Linda Vista, Mid-City: City Heights, Mid-City: Eastern Area, Midway-Pacific Highway, Old Town, Otay Mesa, Otay Mesa-Nestor, San Ysidro, Skyline-Paradise Hills, Southeastern San Diego, and the portion of the Uptown community within the 92101 zip code. This list of Preliminary Focus Areas used in this report may change as the planning process for Environmental Justice Element progresses.

The survey was available to the public through City of San Diego Planning Department website’s Environmental Justice Element webpage, and can be found [here](#) (English version). It was available in 10 languages, including those most spoken by residents in the City of San Diego as a whole and those spoken by residents in “Preliminary Focus Areas:” English, Spanish, Vietnamese, Mandarin Chinese, Tagalog, Arabic, Somali, Swahili, Karen, and Burmese. The survey was promoted through Environmental Justice Element informational interviews with community-based organization, presentations at community planning group meetings in Preliminary Focus Areas, announcements at general and project-specific community group

meetings, and announcements through traditional and social media channels in English and Spanish. In addition, the survey was shared to the community groups' community contact networks through email; emailed to a list of stakeholders and community organizations gathered by Planning Department staff, and shared with library patrons in Preliminary Focus Areas through English and Spanish flyers distributed through the central and branch libraries and through English and Spanish posted posters at those libraries.

## Survey Questions

The survey contained 12 questions. Two questions asked about the key Environmental Justice issues which were identified in SB 1000 in order to identify and prioritize issues being experienced by San Diego residents. Two questions were asked to identify the area in which the respondent lives. Six questions asked for participant's demographic information in order to assess risk factors for pollution and health burdens. Two questions were asked to gauge how easy it was to complete the survey, in order to assess whether the survey was understandable and able to be completed. At the end of the survey respondents could optionally provide their personal contact information to support continued engagement in the Environmental Justice Element planning process.

The survey questions were as follows:

**1. Which three issues do you think are most important for the City to address to ensure all neighborhoods have access to healthy living conditions and environments? [Please select no more than three]**

- Air pollution from vehicles on streets and freeways.
- Air or chemical pollution from industrial businesses and activities.
- Limited access to healthy food and grocery stores.
- Health care access, and availability of paramedic services.
- Concerns about housing access, safe housing, and healthy housing.
- Concerns about how the City engages with residents and makes decisions that affect community health and environmental issues.
- Problems with or lack of city infrastructure and facilities that support physical activity, including sidewalks, bicycle lanes, parks, and recreation centers.

**2. Are there conditions impacting your community that make it difficult for residents to have good health and living conditions? [Select as many options as you wish]**

- Air pollution from freeways.
- Air pollution from businesses.
- Air pollution from trucks.
- Fumes, noise, and/or chemicals from current industrial businesses or gas stations.
- Pollution at the location of past industrial businesses.
- Water pollution in creeks, canyons, and storm drainage areas.
- Dumping trash and other items in creeks, canyons, and storm drainage areas.
- Access to grocery stores, neighborhood markets and farmers markets, and other affordable healthy food options.
- Access to additional food purchase or nutrition assistance.
- Sidewalks, crosswalks, and safety for people who walk and use mobility devices such as wheelchairs.
- Bicycle lanes and safety for people who use bicycles to get around.

- Buses and trolleys that get me to where I want to go.
- Access to health care services like doctors, dentists, and hospitals.
- Access to mental health care services.
- Feeling safe outside my house.
- Finding enough shade outside my house from street trees and trees in parks.
- Access to parks and recreation centers.
- Opportunities for activities and sports at neighborhood parks.
- Availability and affordability of organized activities and sports at neighborhood parks and recreation centers.
- Feeling safe at parks and recreation centers.
- Being able to get to the beach and/or bays.
- Feeling safe at the beach and/or bays.
- Availability of affordable health care services (doctors, mental health professionals, dentists, hospital, health insurance).
- Availability of health care services that are open at times that work for people who work during evenings and weekends.
- Availability and response time of fire department and paramedic services.
- Lead-based paint in homes.
- Dust containing lead in homes or yards.
- Areas that are at risk of flooding or wildfire near homes.
- Affordability of or access to air conditioning.
- Availability of affordable flood insurance, fire insurance, or renter's insurance that covers flood and fire.
- Ability to find or access information about decisions that the City is considering and/or opportunities for residents to share their thoughts on City proposals.
- Ability to find and access information about City proposals and decisions that could affect residents.
- Availability of information about City proposals or decisions in multiple languages spoken by City residents.
- Availability of information on City proposals or decisions in a communication method (such as American Sign Language, Lengua de Señas Mexicana, large print, screen reader compatible web page or document) that meets the needs of disabled residents.
- Ability to participate in City meetings at a time and through a communication channel (i.e. phone, video meeting, email) that works for residents.
- Unsafe or unhealthy conditions in homes (such as mold, poor ventilation, needed repairs to ceiling or other parts of structure, or kitchen or bathroom that doesn't meet my needs or needs repair).

## Survey Response Summary

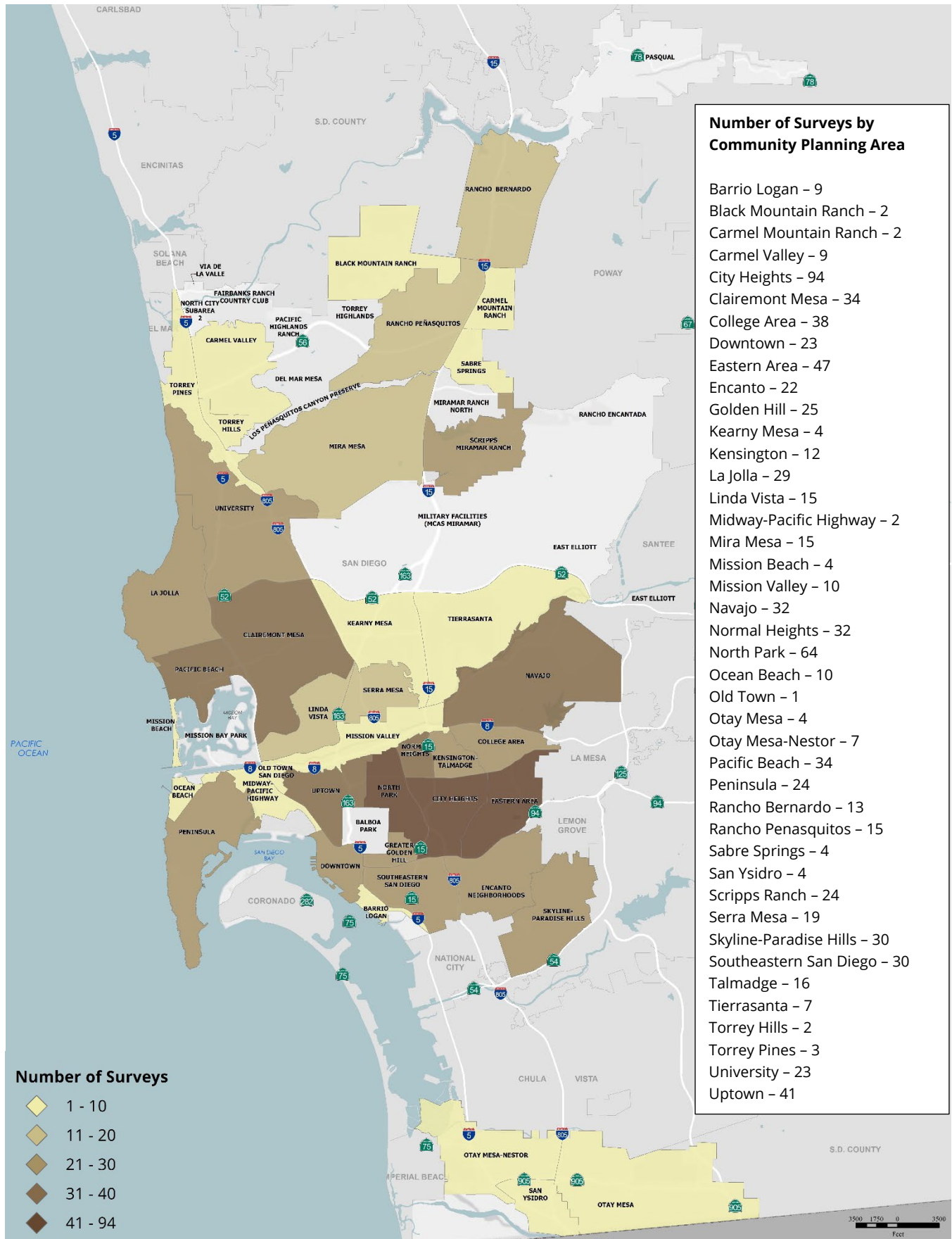
The survey received 890 responses, of which 835 responses were submitted by City of San Diego residents and 55 were submitted by residents of communities outside of the City's jurisdiction. The responses to the neighborhood and zip code questions were used to determine which community planning areas respondents live in. Map 1 below shows the range of responses by community planning area. Preliminary Focus Areas from which less than 10 responses were received are Barrio Logan, Midway-Pacific Highway, Otay Mesa, Otay Mesa-Nestor, and San Ysidro.

The demographic characteristics (age, race/ethnicity, level of formal education, household income, and household people of interest) of the City residents who responded to the survey are discussed in the Survey Taker Demographics section of this report. The Environmental Issues and Concerns Questions section of this report provides a summary of responses to each of the two environmental survey questions. It also provides comparison graphs looking at relationships between issues that people care about and survey taker demographics.

Comparison of issues concerning people from Preliminary Focus Areas and those concerning people living in other communities is also provided in this report. A summary of responses to the survey questions regarding environmental justice priorities and community conditions (questions 1 and 2 above) for each community can be found Appendix A. Additional demographic analysis and environmental issue analysis by community is found in an accompanying Excel spreadsheet that is available on the Environmental Justice Element webpage at <https://www.sandiego.gov/planning/programs/genplan/environmentjustice>.

It is important to note this is not a statistically valid survey. The survey did not capture a representative sample of a cross-section of San Diego residents nor Preliminary Focus Areas residents. The survey was self-selecting, meaning people who took the survey sought to communicate their experiences to the Planning Department which was seeking input. The demographic questions provide insights into the people who chose to take the survey. Although not statistically valid to represent the opinions of all community residents, the survey responses are still informative because they provide initial insight into community residents' environmental concerns and will inform further research and outreach in future project phases.

**Map 1: Survey Responses by Community Planning Area**



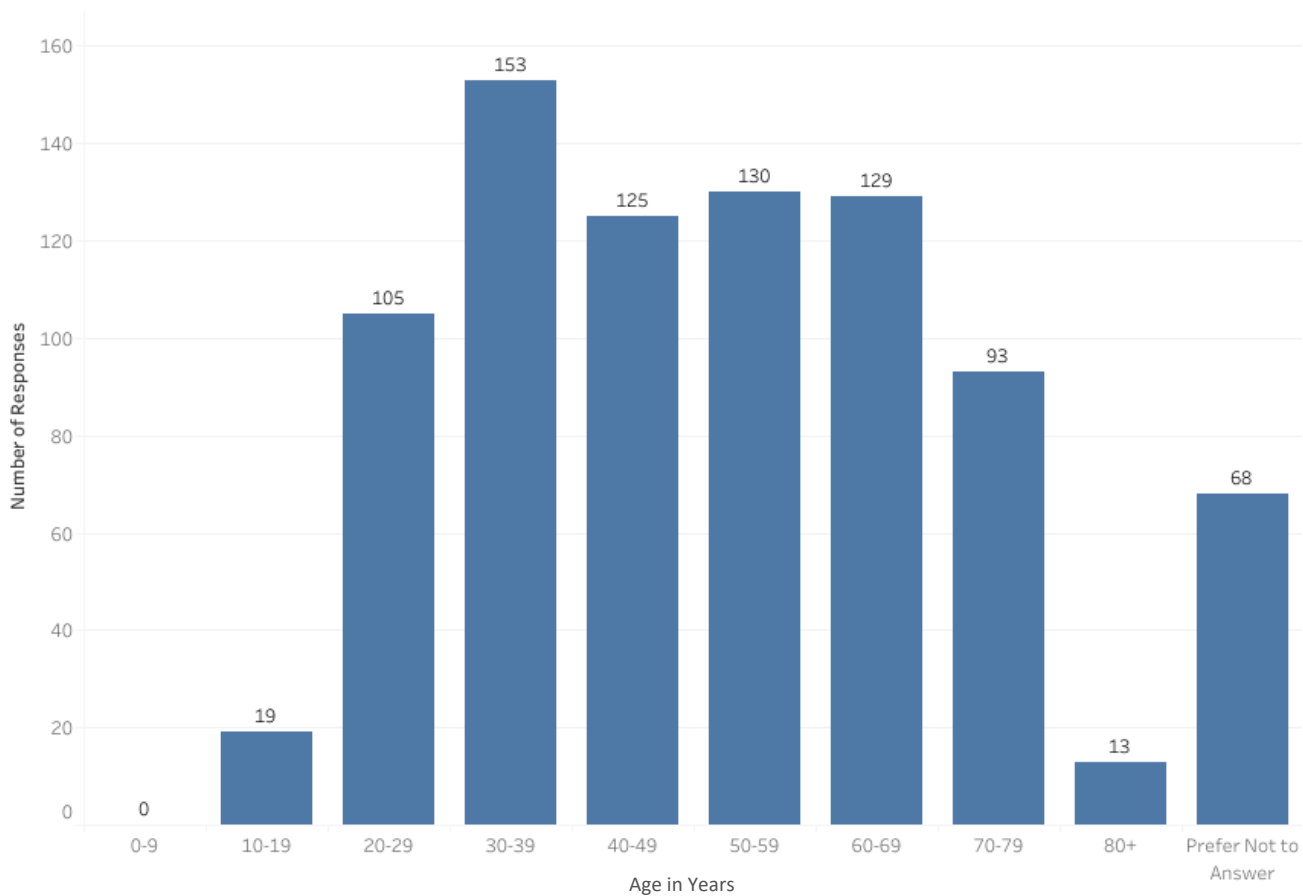
## Survey Taker Demographics

### Age

- **Survey Question: What is your age in years?**

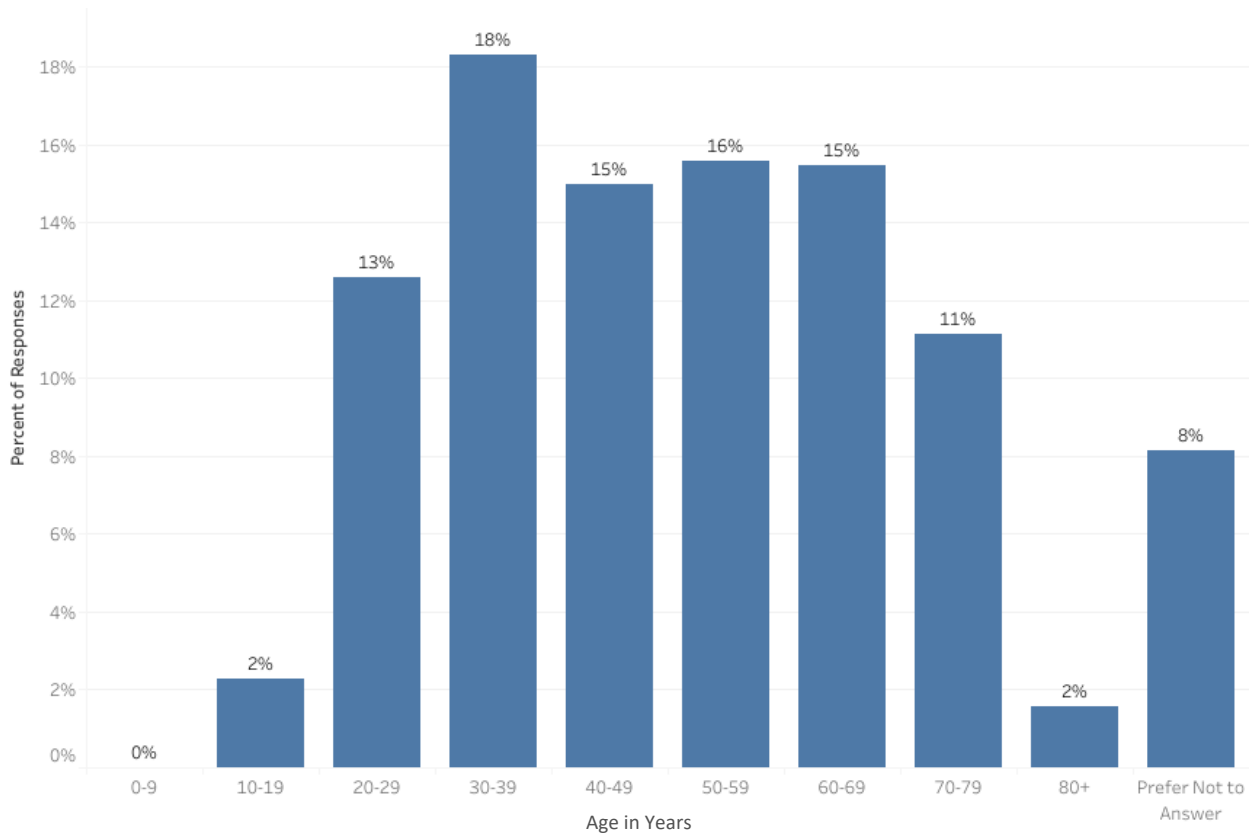
Survey takers were asked about their ages for two reasons: first, because people in different age ranges, including children and seniors, can be susceptible to different health challenges resulting from pollution and other environmental justice conditions; and second, to understand how the survey takers compare to all City residents with regard to age. Responses to the question about the survey taker's age were categorized into 10-year ranges, as you can see in Graph 1. The age ranges with the highest number of responses are 30 to 39 years (with 153 responses), 50 to 59 years (with 130 responses), and 60 to 69 years (with 129 responses). The age ranges with the lowest number of responses were 0 to 9 years (no responses) and 80 years and older (13 responses). Sixty-eight survey takers preferred not to provide their age.

**Graph 1: Survey Responses by Age in Years**

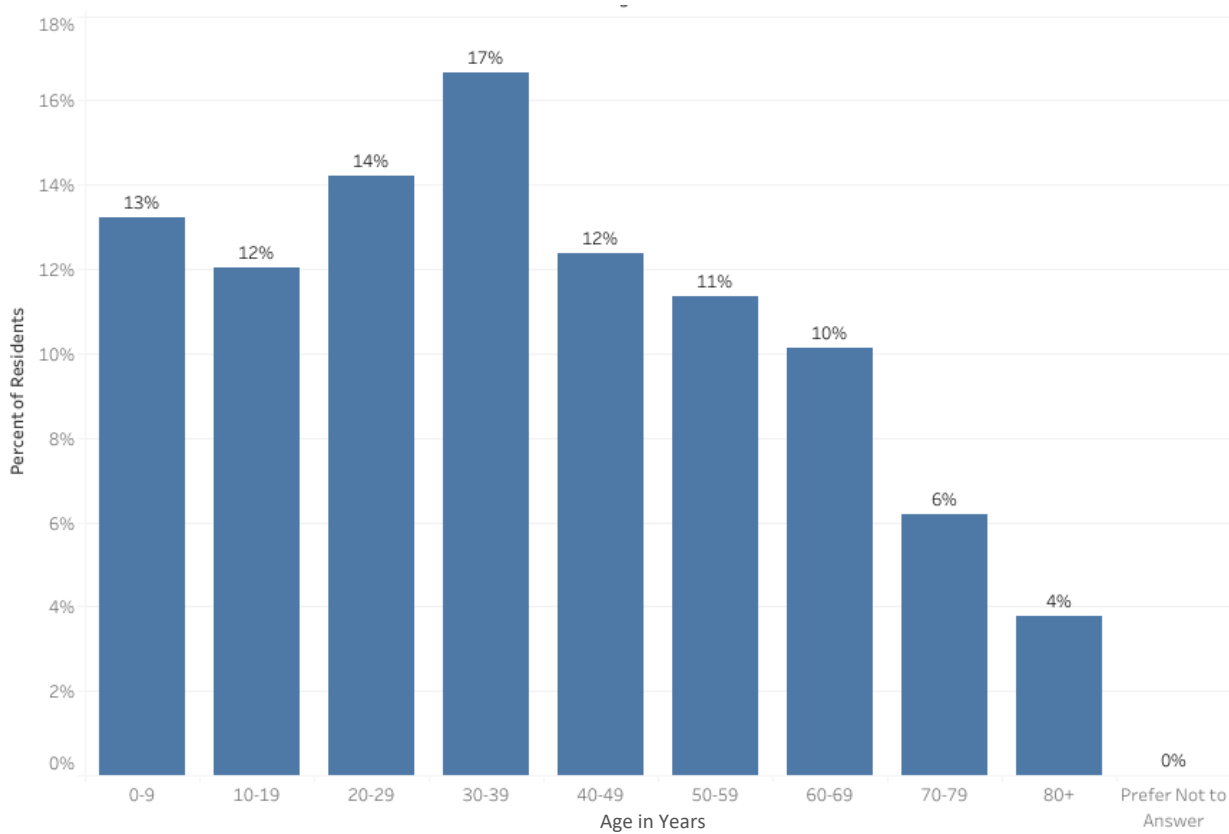


Graph 2 shows the percentage of survey takers in each age range, and Graph 3 shows the percentage of City residents in each age range. The proportion of survey takers in the 20 to 29 and 30 to 39 age ranges were within one percent of the proportion of City residents in the same age range. Many fewer youth ages 0 to 9 and 10 and 19 and seniors ages 80 and higher responded to the survey than their proportion of City residents. Also, more adults ages 40 to 49, 50 to 59, 60 to 69, and 70 to 79 took the survey than their proportion of the total City population.

**Graph 3: City Residents by Age in Years, as a Percent of Total City Residents**

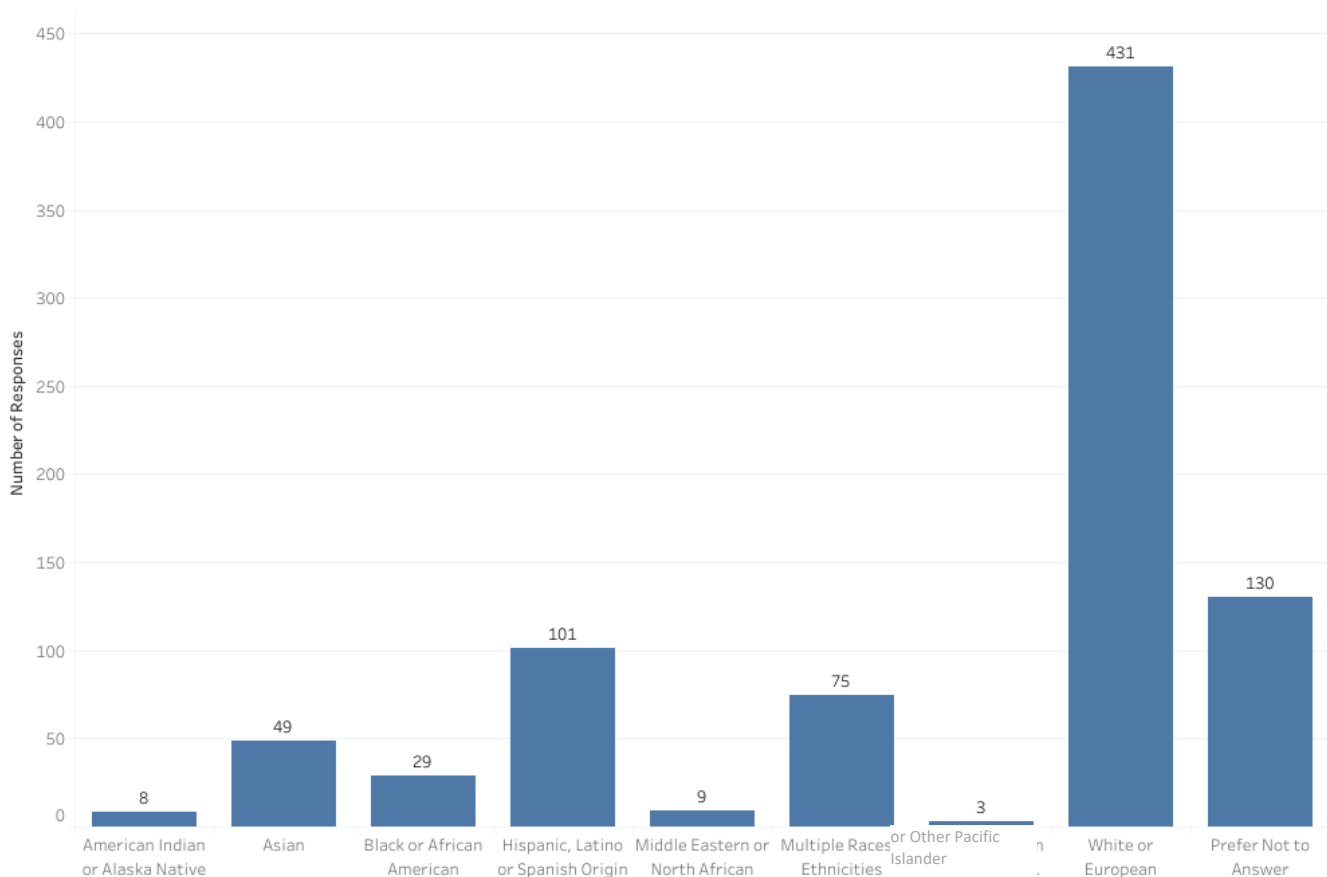


## Race/Ethnicity

- **Survey Question: Which race/ethnicity category best describes you? Select all that apply to you.**

Survey takers were asked about their race/ethnicity because people of color, in particular Black, Hispanic/Latino, and Native American people, experience systemic racism, including higher rates of exposure to harmful environmental conditions<sup>1,2</sup> and lower incomes with which to access healthy living conditions<sup>3</sup>. While some City residents of White or of European origin experience harmful environmental conditions, people of color experience a greater number and severity of poor environmental conditions. Therefore, it is helpful to understand the racial/ethnic identities of residents who took the survey. Graph 4 shows the survey takers' race/ethnicity, and Graph 5 shows survey takers' race/ethnicity as a proportion of total responses. The largest number and percentage of responses were received from residents of White or European race/ethnicity, followed by residents of Hispanic or Latino race/ethnicity and residents of multiple races/ethnicities. Graph 6 shows the percentages of total City residents in the race/ethnicity groups. Fewer survey responses were received from residents in the Asian, Black or African American, and Hispanic or Latino groups than their proportion of City residents; and more responses were received from residents in the White or European and Multiple Races/Ethnicities groups than their proportion of City residents.

**Graph 4: Survey Responses by Race/Ethnicity**

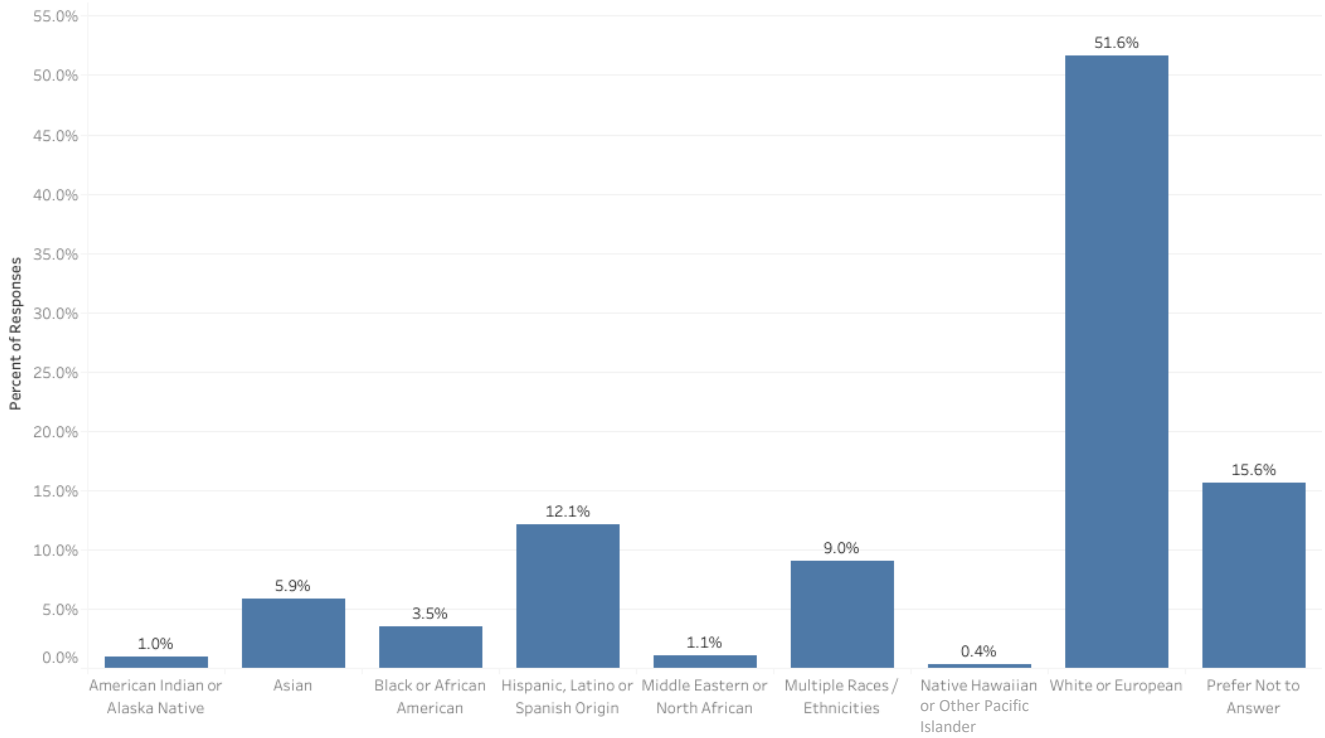

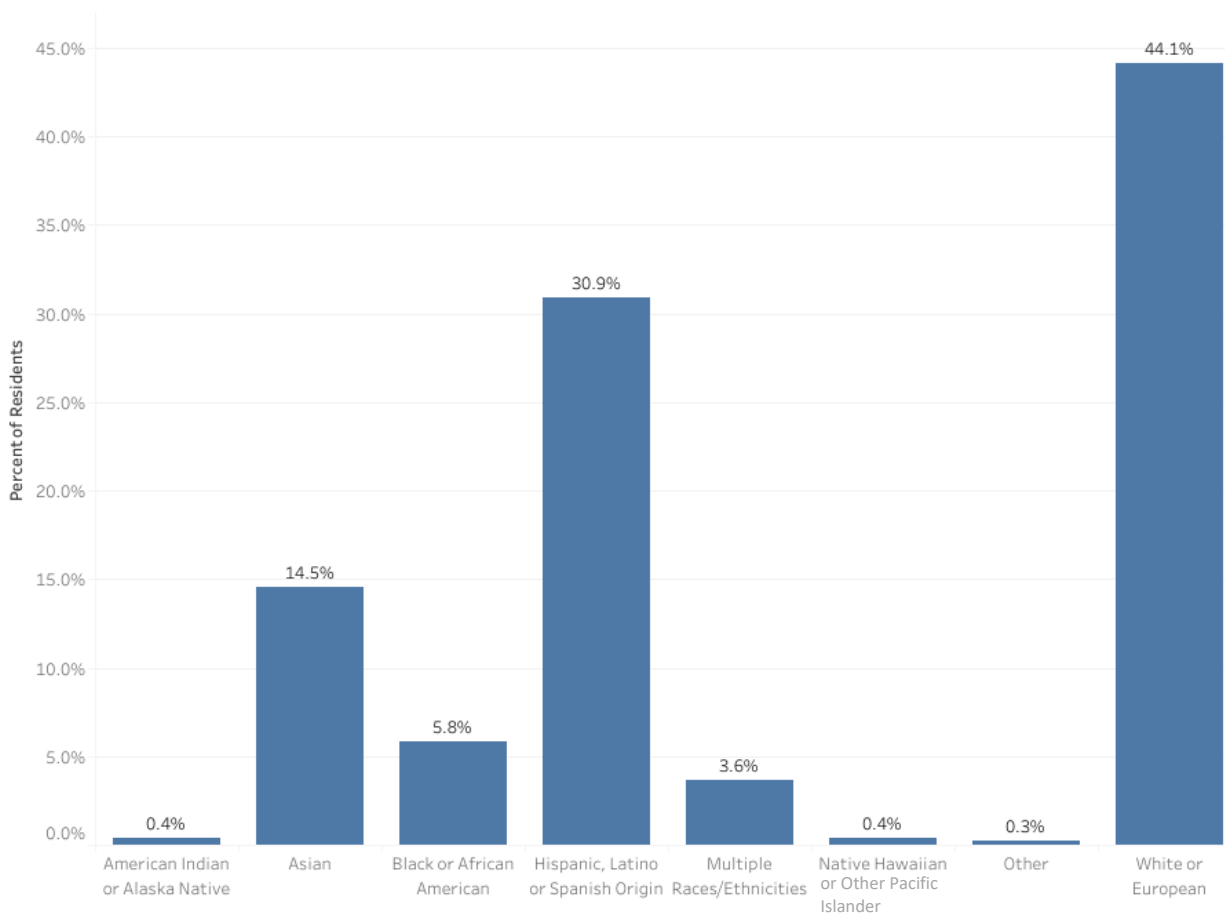

**Graph 6: City Resident Race/Ethnicity, as a Percent of Total Residents**



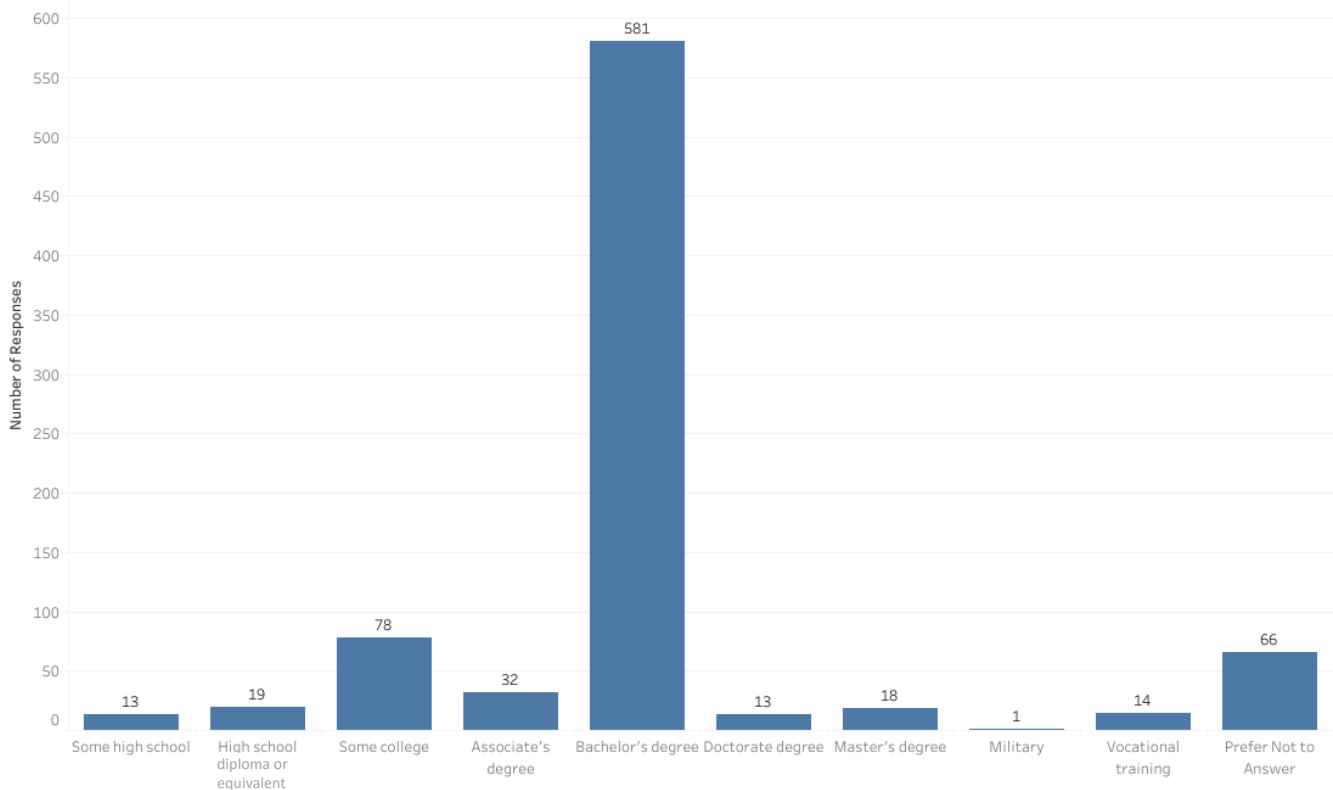
## Level of Formal Education

- **Survey Question: What is your education level?**

Level of formal education relates to income level, as people with higher levels of formal education tend to have higher median incomes and lower unemployment rates<sup>3</sup>. People with lower incomes are also more likely to experience harmful environmental conditions than people with higher incomes<sup>4,5</sup>, and have fewer resources with which to access healthy living conditions. Therefore, it is helpful to understand the formal education level of residents who took the survey.

Graph 7 shows the survey takers' formal education level, and Graph 8 shows the same information as a proportion of total responses. The largest number (581 surveys) and percent of responses (69.6%) were received from residents with formal education up to the Bachelor's degree level. According to the U.S. Census Quick Facts for 2015 to 2019, 38.8% of City residents have a Bachelor's degree or higher level of formal education.

**Graph 7: Survey Responses by Highest Level of Formal Education**

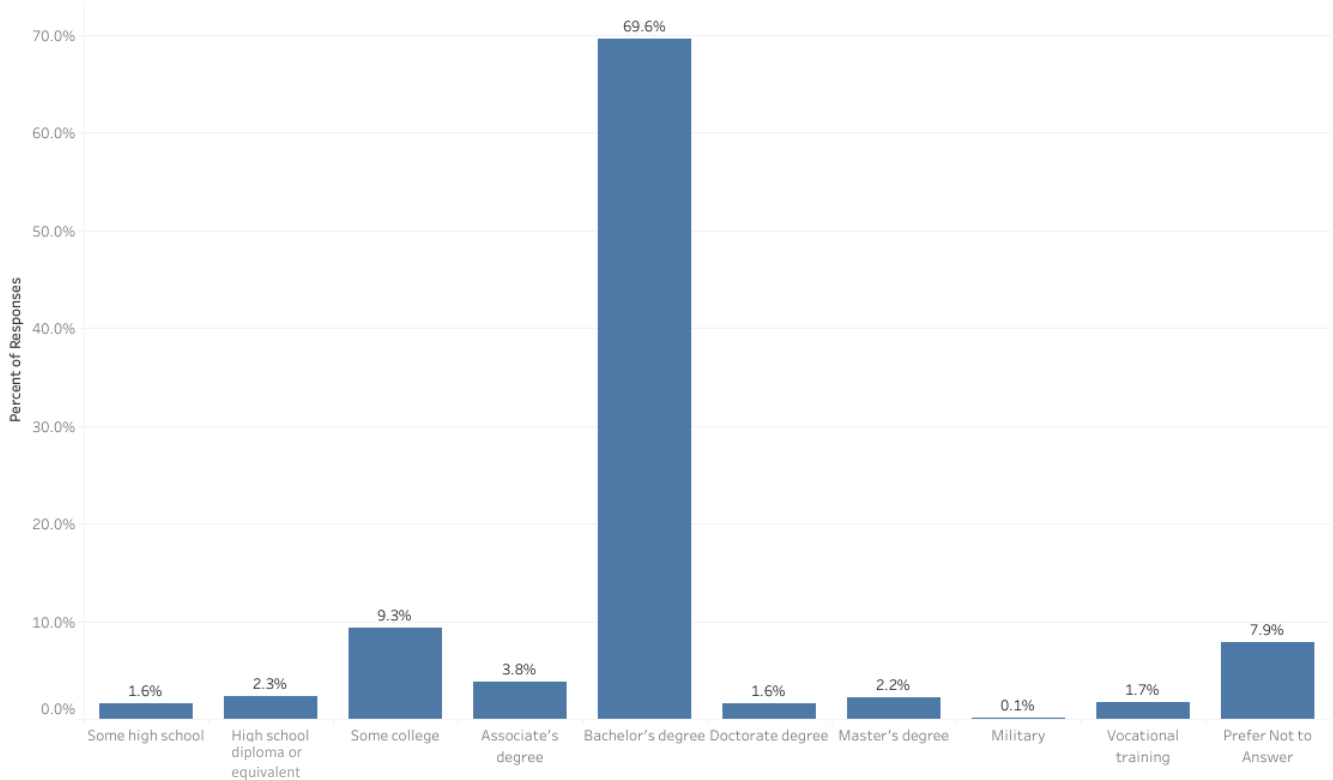

**Graph 8: Survey Responses by Highest Level of Formal Education, as a Percent of Total Responses**

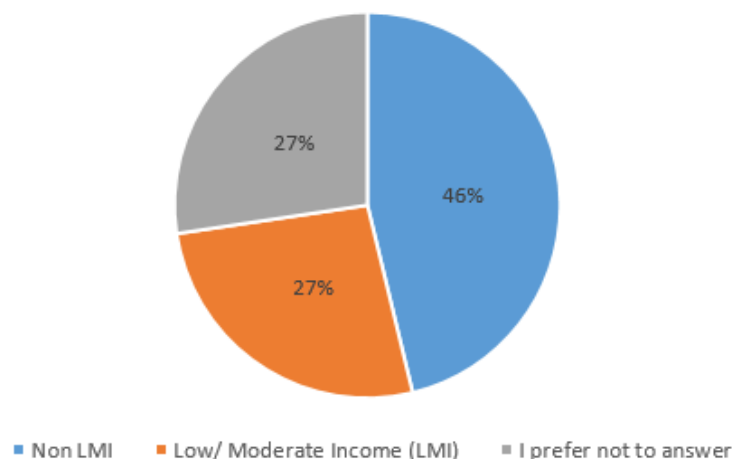


**Household Income**

- **Survey Question: How many people live in your household?**
- **Survey Question: How much total money did all members of your household earn in 2019?**

As mentioned above, people with lower incomes are more likely to experience harmful environmental conditions than people with higher incomes. Therefore, it is helpful to understand the household income level of residents who took the survey. Responses about number of people per household and household income were used to determine household income level based on the Department of Housing and Urban Development’s household income level limits for San Diego County. Survey takers were categorized as having a Non-Low/Moderate Income (Non LMI) or a Low/Moderate Income (LMI), as shown in Graph 9.

**Graph 9: Survey Responses by Household Income Level**



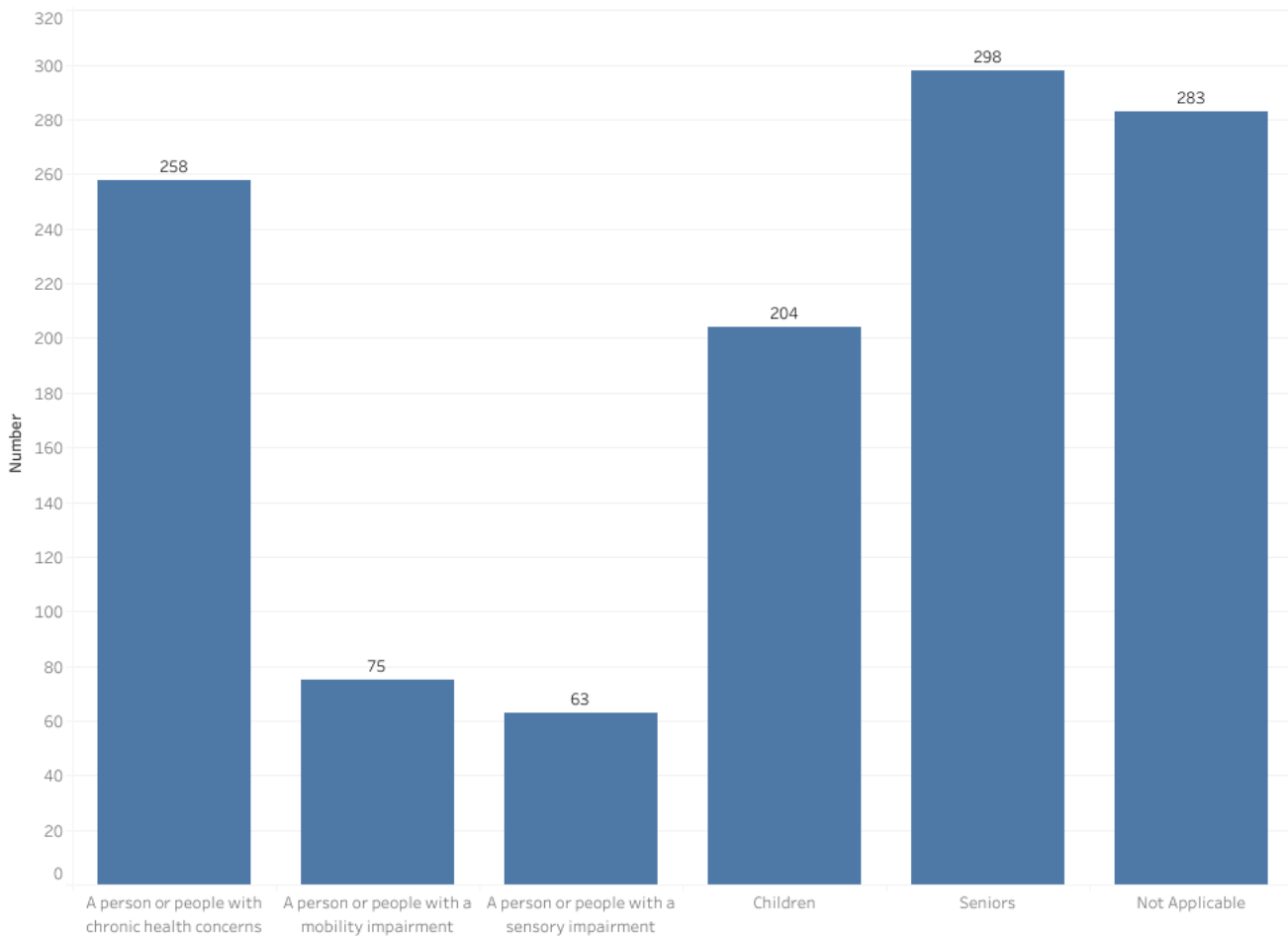


## Household People of Interest

- **Survey Question: Does your household include any of the following people?**
  - **A person or people with chronic health concerns**
  - **A person or people with a mobility impairment**
  - **A person or people with a sensory impairment**
  - **Children**
  - **Seniors**

The types of people listed in this question, which we will call “people of interest,” are often most affected by poor environmental conditions. Chronic health concerns, such as asthma, heart disease, diabetes, and lung disease can both worsen the effects of pollution and poor environmental conditions and lower incomes and increase risk of other health concerns. Asthma is a common long term disease in children and also affects adults. Outdoor air pollution can trigger asthma attacks or make asthma worse. People with asthma can be especially susceptible to pneumonia, flu and other illnesses. Childhood lead exposure can result in cognitive impairment and blood, kidney, and endocrine toxicity. Historically-used lead persists in paint, old plumbing, and contaminated soil. Lead house paint is the most significant source of lead exposure in children. People with mobility or sensory (hearing or sight) impairments may experience more challenges with mobility and activity, especially where missing, damaged, poor condition, or outdated infrastructure exists such as sidewalks, pavement, curb ramps, audible crossing signals, and parks and recreation facilities. Seniors are more likely than younger people to experience mobility and sensory impairments. Therefore, it is helpful to know if a survey taker’s household include people of interest.

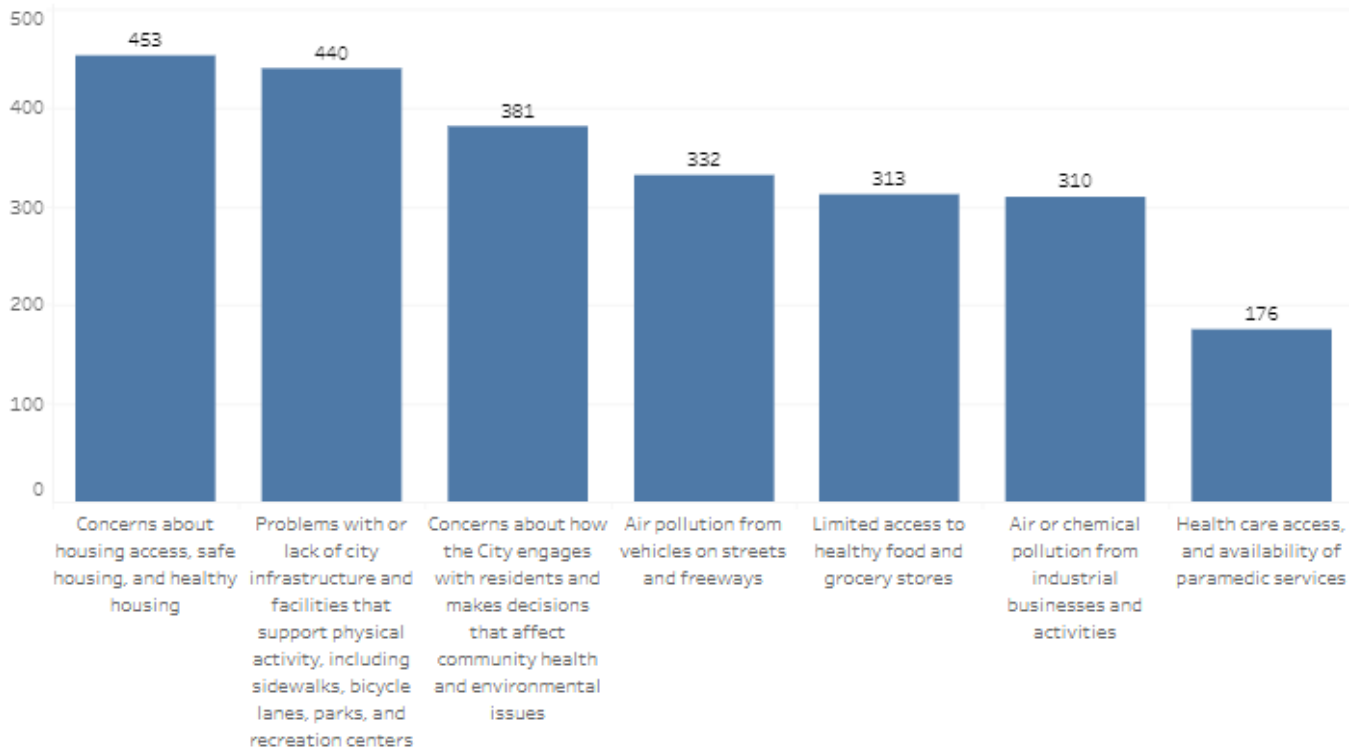

  - Concerns about how the City engages with residents and makes decisions that affect community health and environmental issues.
  - Air pollution from vehicles on streets and freeways.
  - Limited access to healthy food and grocery stores.
  - Air or chemical pollution from industrial businesses and activities.
  - Health care access, and availability of paramedic services.

The three environmental issues which received the highest number of responses are “Concerns with about housing access, safe housing, and healthy housing” (453 responses), “Problems with or lack of city infrastructure and facilities that support physical activity, including sidewalks, bicycle lanes, parks, and recreation centers” (440 responses) and “Concerns about how the City engages with residents and makes decisions that affect community health and environmental issues” (381 responses).

**Graph 11: Environmental Justice Conditions (Top Three Issues) – Count of Responses**



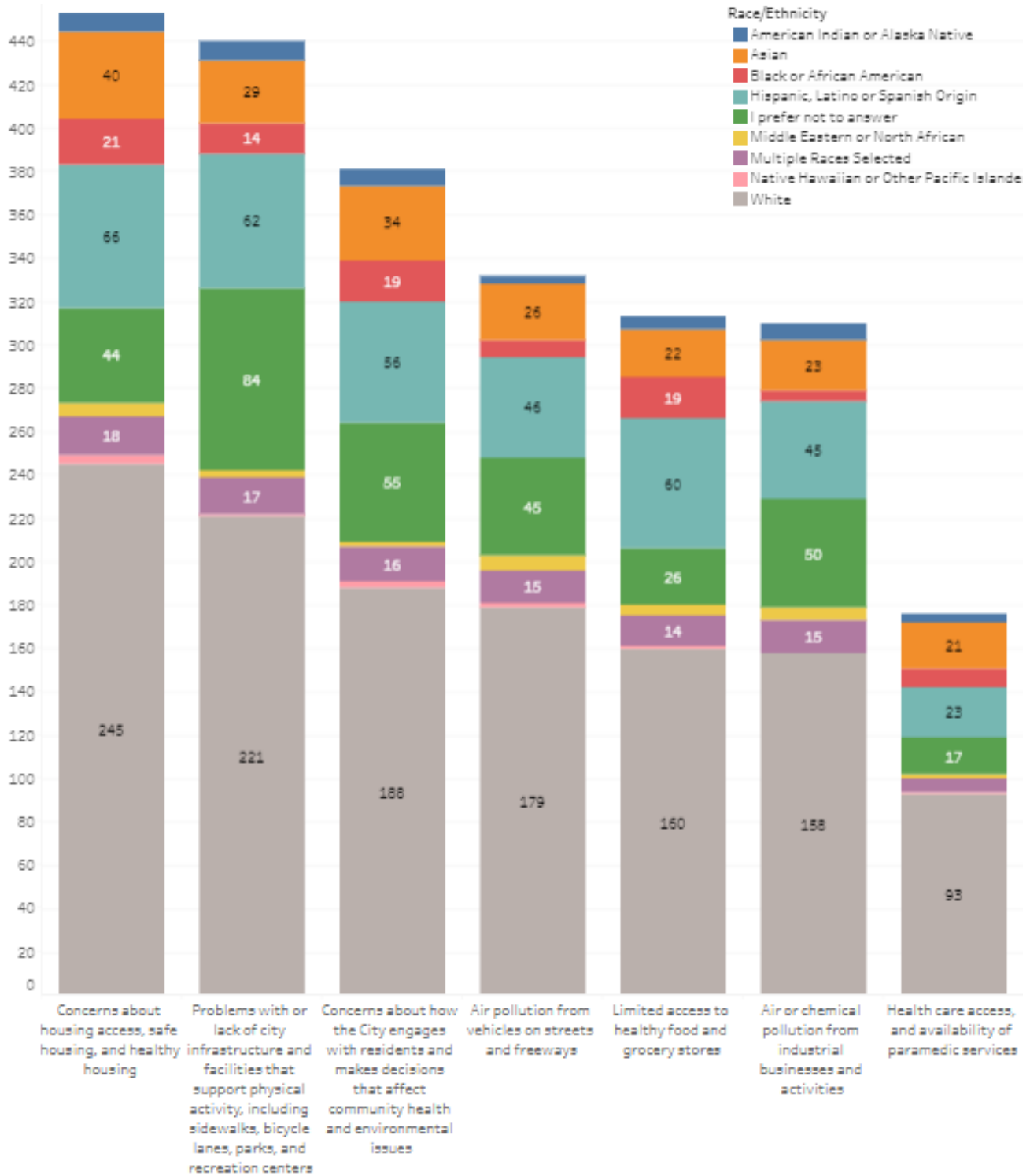
## Environmental Justice Priorities – Demographics Analysis

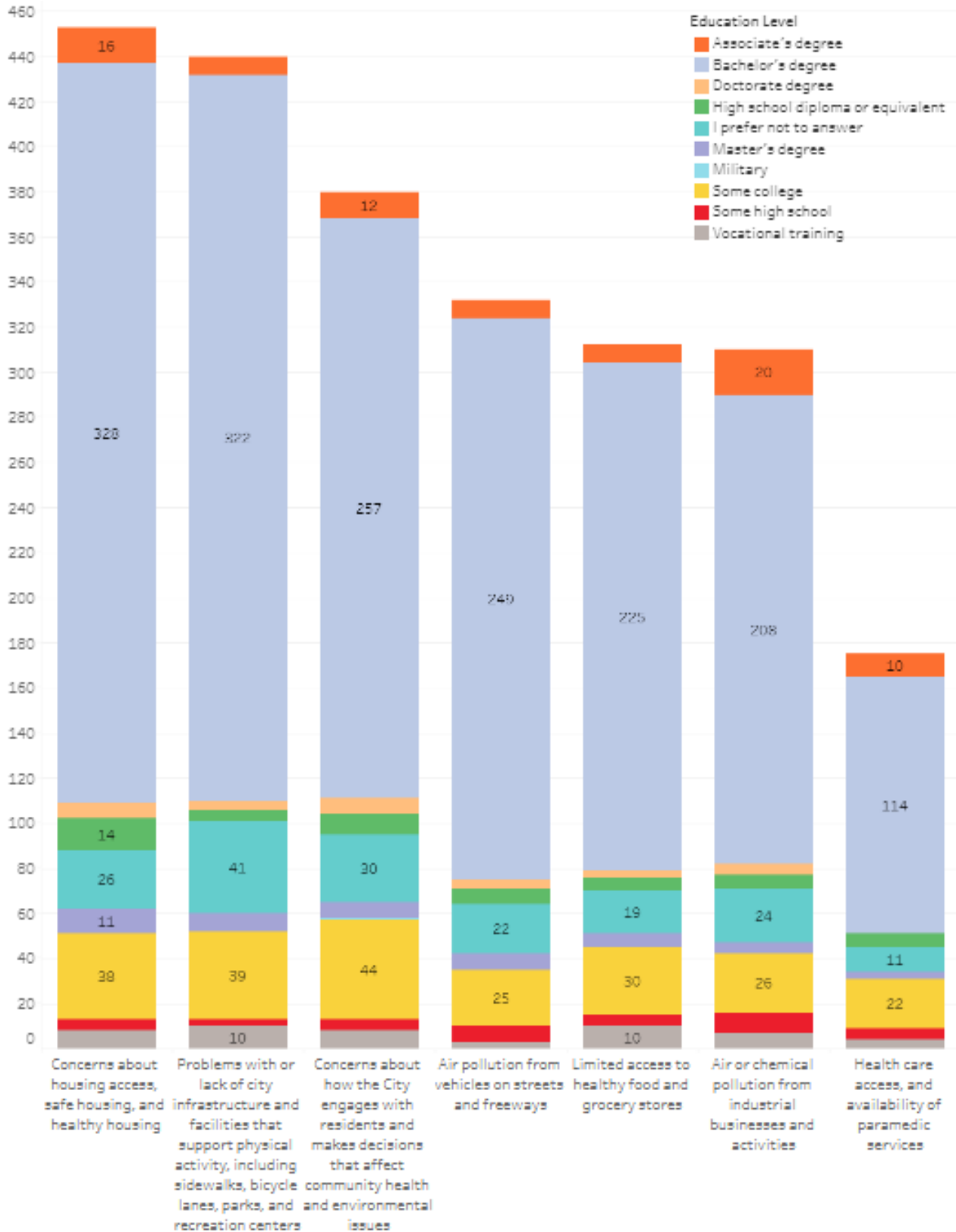

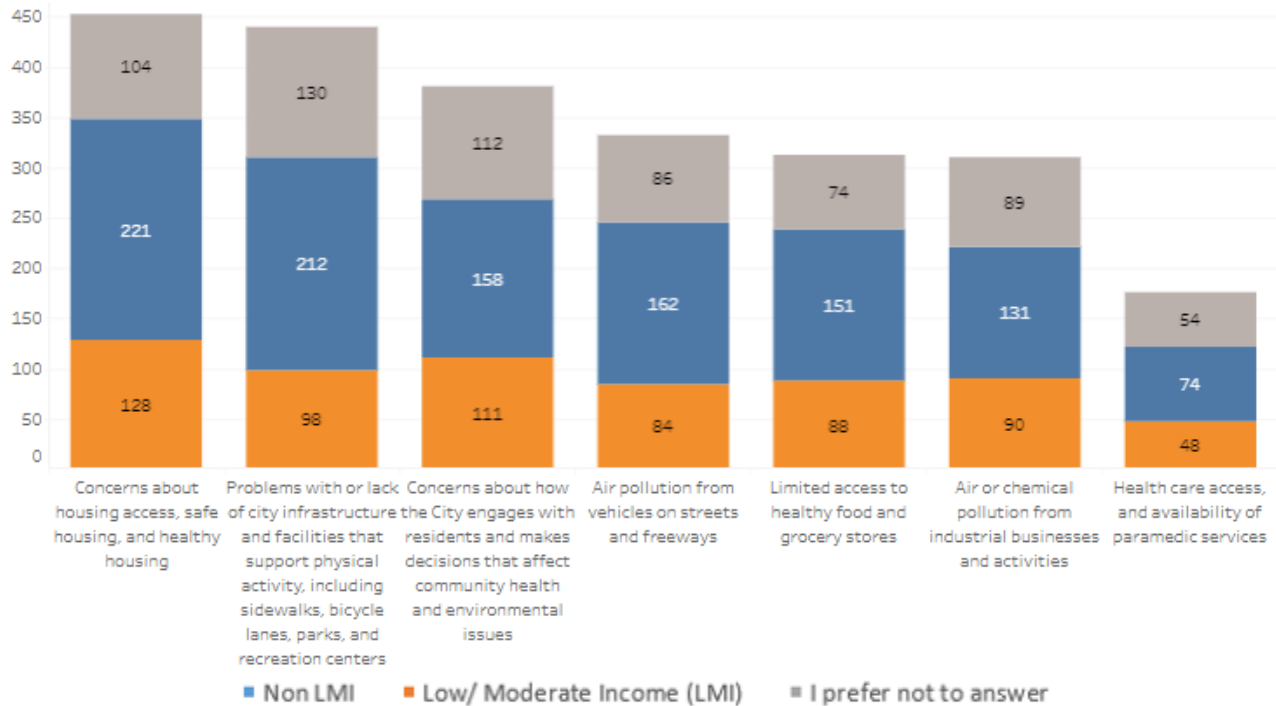
**Graph 12: Environmental Justice Priorities (Top Three Issues) By Race/Ethnicity**

## **Community Environmental Conditions**

### **Community Environmental Conditions – Question and Responses**

- **Survey Question: Are there conditions impacting your community that make it difficult for residents to have good health and living conditions? [Select as many options as you wish]**

The most commonly reported community environmental conditions are dumping of trash in creeks, canyons, and storm drains; air pollution from freeways; challenges finding and accessing information about City decisions that could affect residents; and challenges finding or accessing information about decisions that the City is considering and opportunities for residents to share their thoughts. Table 2 provides a count of responses for all issues listed or provided by survey takers in this question.

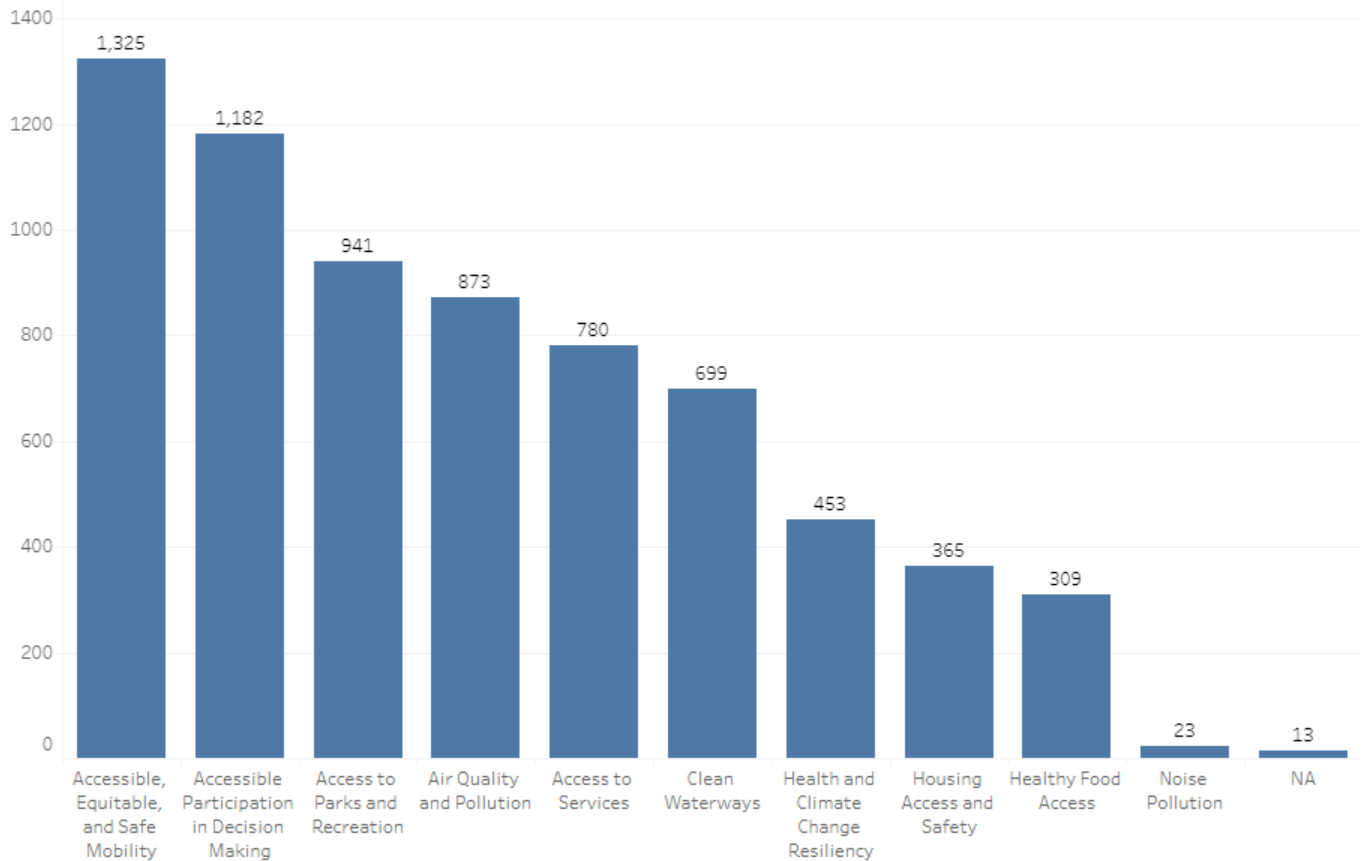

As shown in Graph 15, the community environmental conditions categories that had the highest number of responses were Accessible, Equitable, and Safe Mobility; Accessible Participation in Decision Making; Access to Parks and Recreation; and Air Quality and Pollution. It is worth noting that the number of responses by category could be somewhat influenced by the number of community conditions included in each category, which is larger in some categories than in others.

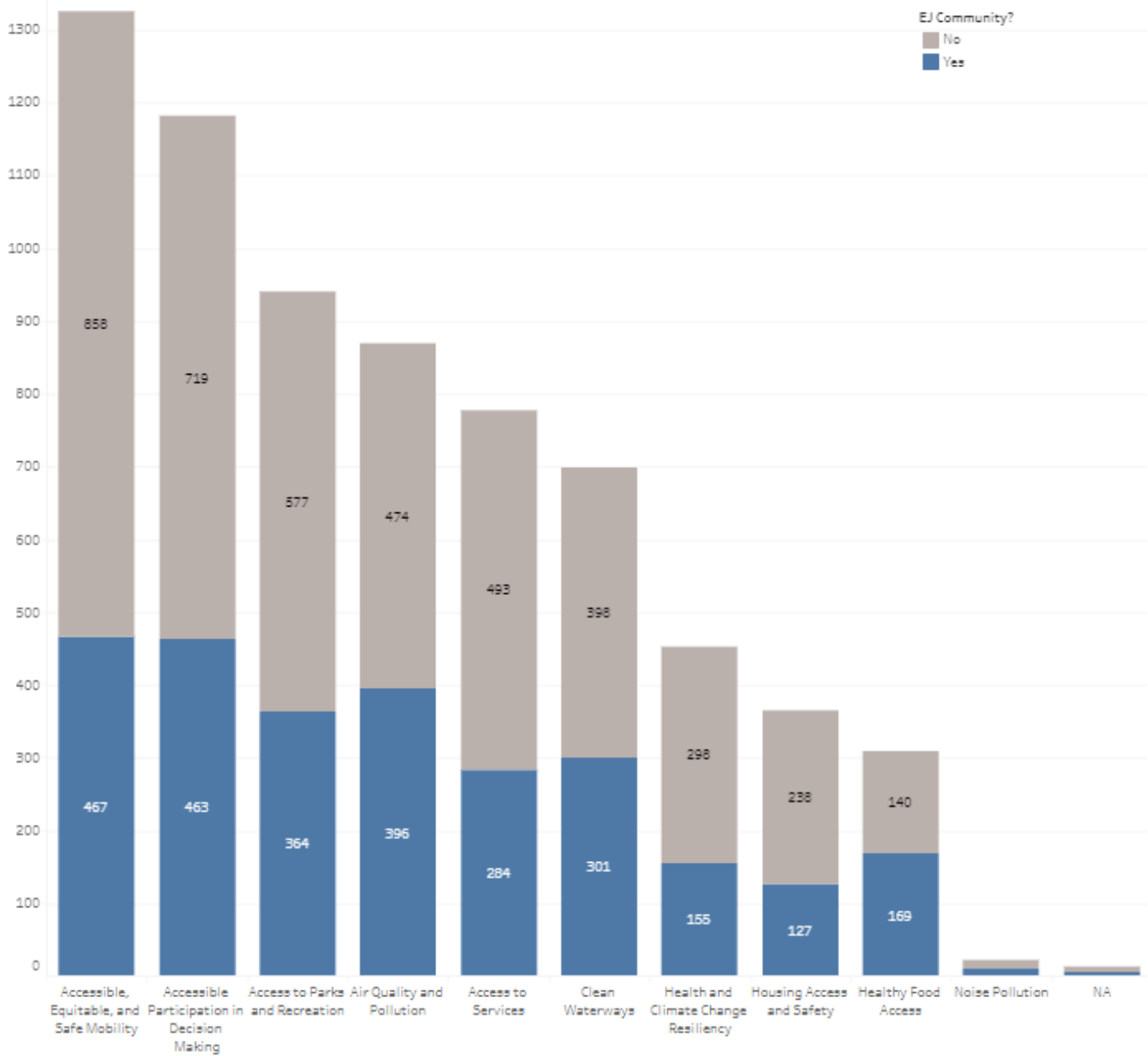
**Graph 15: Community Environmental Conditions Categories - Count of Responses**



Graph 16, on the next page, shows reported community conditions (again sorted into categories) as reported by residents in Preliminary Focus Areas and residents in other areas of the City. Again, there are both similarities in most reported issues and differences how many residents in each type of area reported the issues. Residents in both Preliminary Focus Areas and other areas both reported the highest number of issues in the Accessible, Equitable, and Safe Mobility; Accessible Participation in Decision Making; Access to Parks and Recreation; and Air Quality and Pollution categories. However, more residents in Preliminary Focus Areas identified issues with Air Quality and Pollution than with Access to Parks and Recreation, while residents in other areas reported more issues with Access to Parks and Recreation than with Air Quality and Pollution.

A similar pattern of similarities in top issues and differences between groups in how many residents report different issues appears in issues identified by survey takers in the City's race/ethnicity groups, income level groups, and formal education level groups as shown in Table 3 and Graphs 17, 18, and 19 on the following pages.

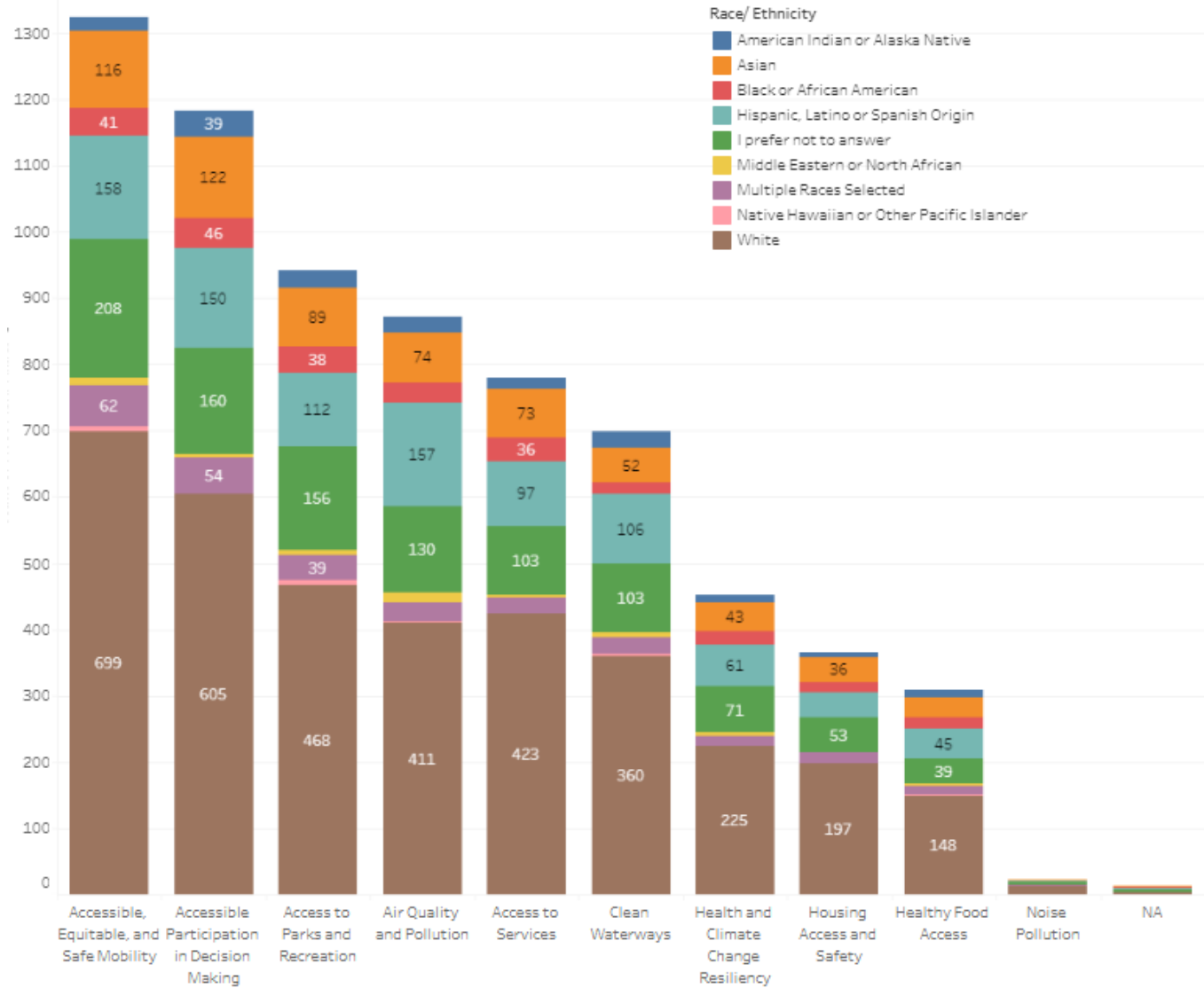
**Graph 16: Community Environmental Conditions Categories – Responses by Preliminary Focus Area/EJ Community (Yes/No)**



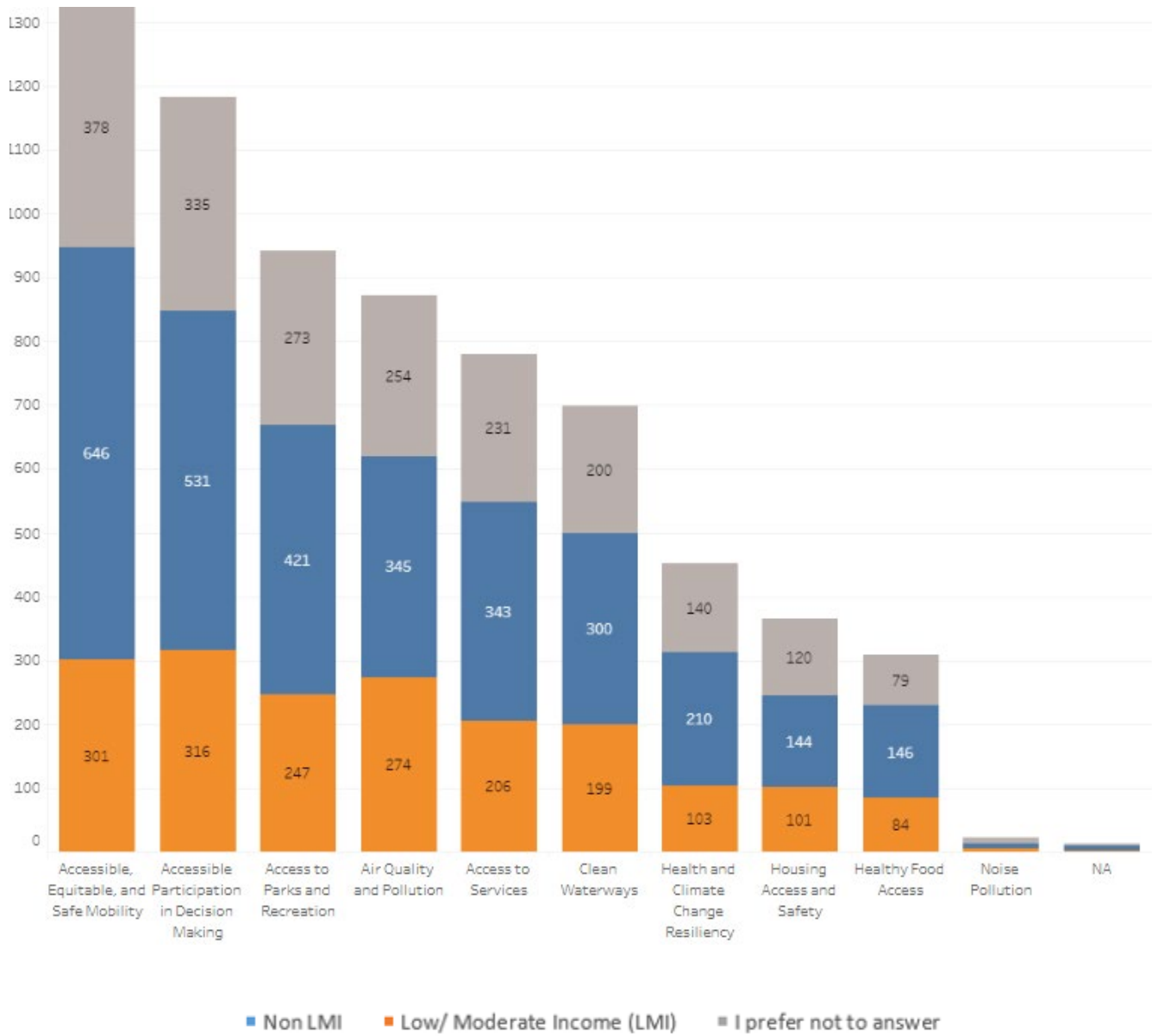

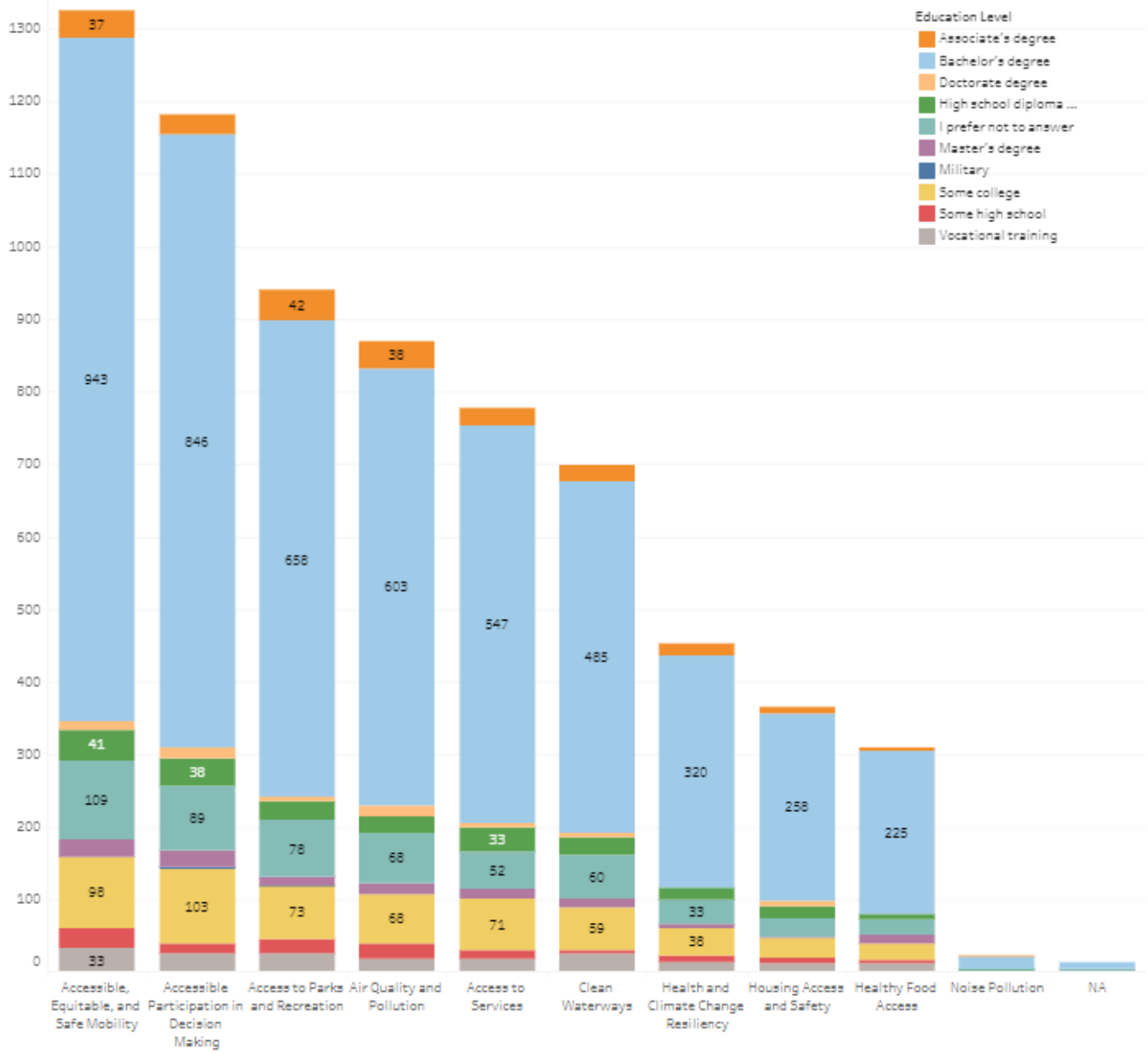
**Graph 17: Community Environmental Conditions Categories By Ethnicity**
