I. Call to Order

The Public Art Committee (PAC) of the City of San Diego (City) Commission for Arts and Culture (Commission) was called to order by Chair Laurie Mitchell at 10:05 a.m.

II. Non-Agenda Public Comment

III. ACTION – November 7, 2013 Minutes

Approved by unanimous consent.

IV. Presentation – Public Art Program Orientation

Dana Springs presented an overview of the Public Art Program, outlining the three primary work areas within the Public Art Program, including Percent-For-Art, Civic Enhancement and Civic Art Collection. Springs explained that public art project management activities undertaken through Percent-For-Art program are guided by Council Policy 900-11, which directs 2% for public art in eligible Capital Improvement Program projects (CIPs). She went on to explain that public art projects undertaken through Civic Enhancement / art in private development program are directed by the San Diego Municipal Code and that eligible private development projects have three options to comply: 1% for public art on site; 1% for cultural space on site; and .5% in-lieu payment to City. Springs described the collection management activities of the Civic Art Collection, which is the third primary Such activities include artwork acquisitions, commissions, deaccessions, incoming loans, outgoing loans, conservation, maintenance, treatment surveys, appraisals, framing, exhibition, storage and photographic and English/Spanish written documentation. Springs briefly explained the City's current organizational structure and how the Commission and PAC fit within it as well as described the Penny for the Arts Five-Year Blueprint which calls for the restoration of Arts, Culture, and Community Festivals allocations within the annual Special Promotional Programs budget to FY 2002 funding levels. In addition, Springs distributed a spreadsheet containing the historic trends of the City's arts and culture funding and briefly reported on the funding mechanisms for the Public Art Program. Springs indicated that she would expand on the topic of funding at the next PAC meeting.

V. Chair's Report

- A. Committee Work Plan Mitchell reported that the Commission annually develops plans and schedules for all its committees and explained activities the PAC will focus on in the primary works areas of the Public Art Program this year. She explained further that the PAC would be addressing two important items later this year, including the expenditure of Civic Enhancement funds and revisions to Council Policy 900-11.
- B. <u>Commission Business</u> Mitchell reported that the City's search for the Commission's Executive Director is in progress and indicated that an appointment may be made by the end of May / early June.
- C. <u>FY15 Budget</u> Mitchell explained the FY15 budget process and reported that it is anticipated that the Mayor will release the proposed FY15 budget in mid April. She explained that the Commission's requested FY15 budget includes the addition of one full-time Associate Management Analyst position for the Commission.
- D. Other Reports Mitchell announced the action items and where they fit within the Public Art Program primary work areas.

VI. ACTION – Artwork Acquisition Proposal: Ernest Silva

Jones summarized the action item: Recommend to the Commission that the Interim Executive Director of the Commission authorize the purchase of the painting titled *Vigilance, Full Moon* by Ernest Silva for inclusion in the San Diego Public Library Visual Arts Program sub-collection of the Civic Art Collection. Jones explained that funds for the purchase are profits from the additional sale of artworks deaccessioned from the Civic Art Collection. Jones explained that recommending not purchasing an artwork at this time was also possible alternative. PAC discussed the acquisition proposal.

<u>Vernon Franck made a motion</u> to purchase the Ernest Silva artwork. <u>Allison Wiese</u> seconded the motion. Discussion ensued. The vote was 7-0-0.
