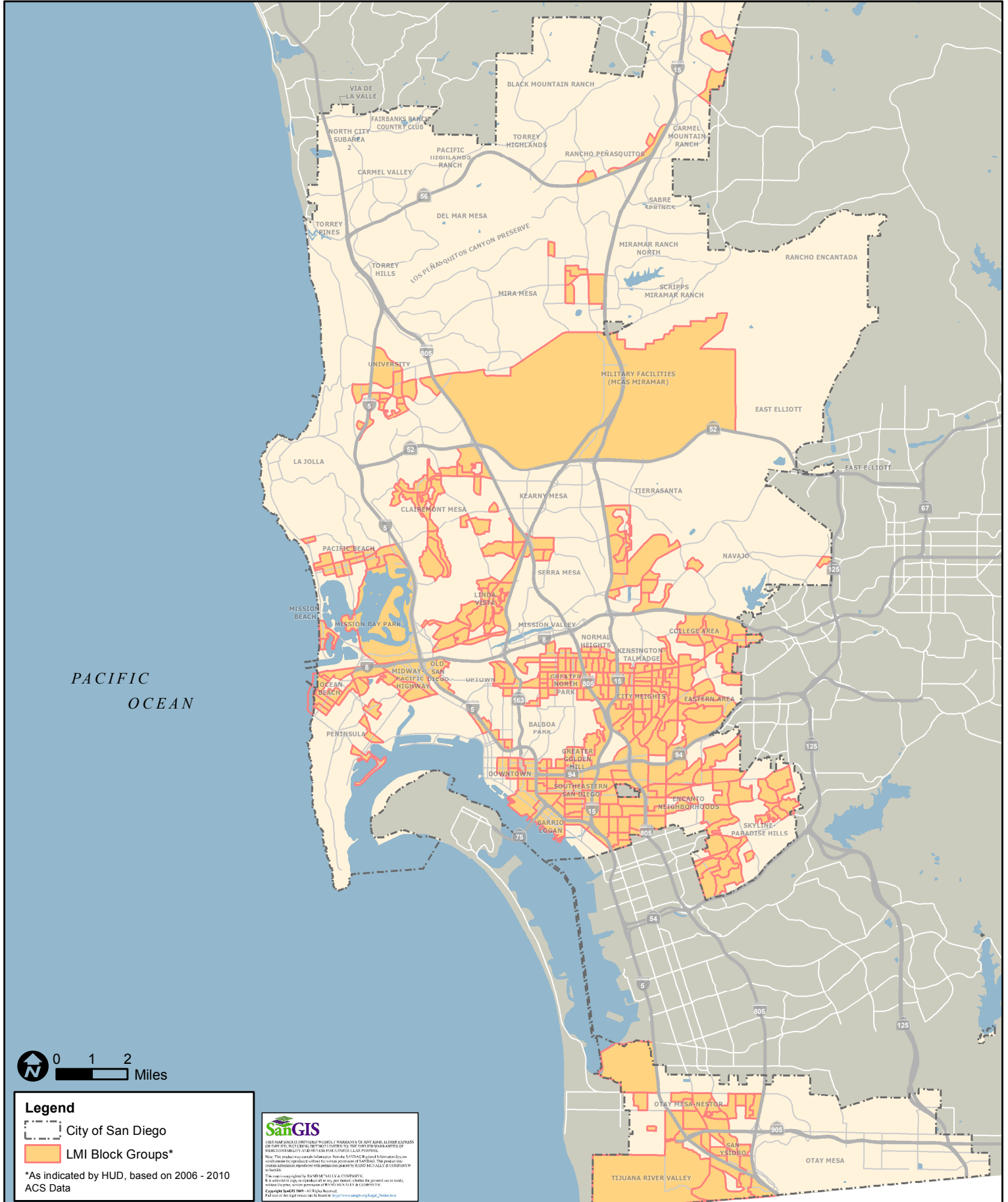

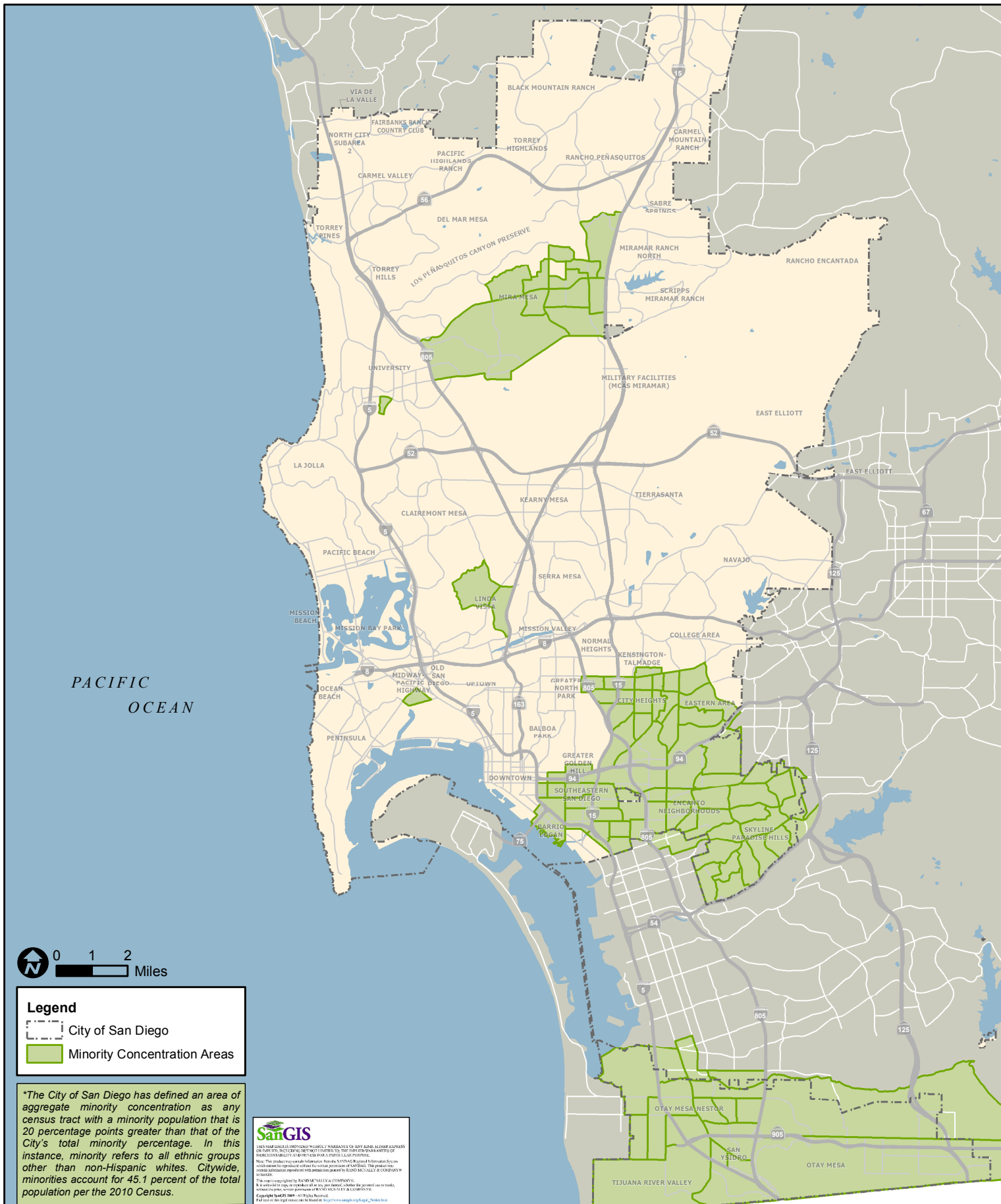

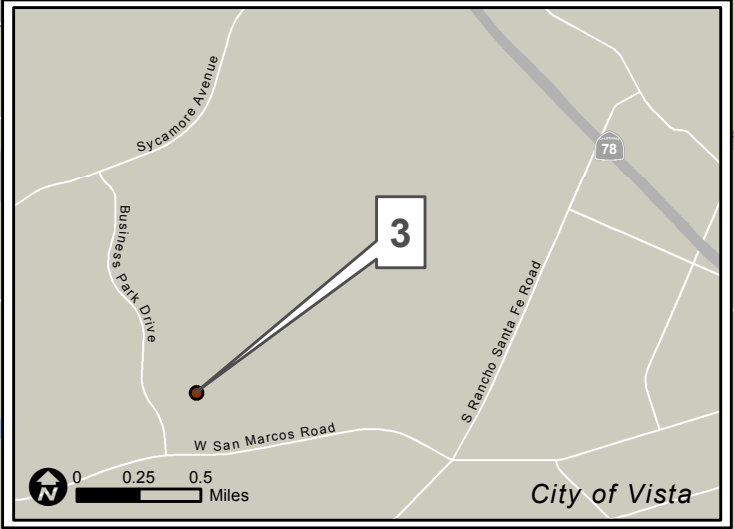

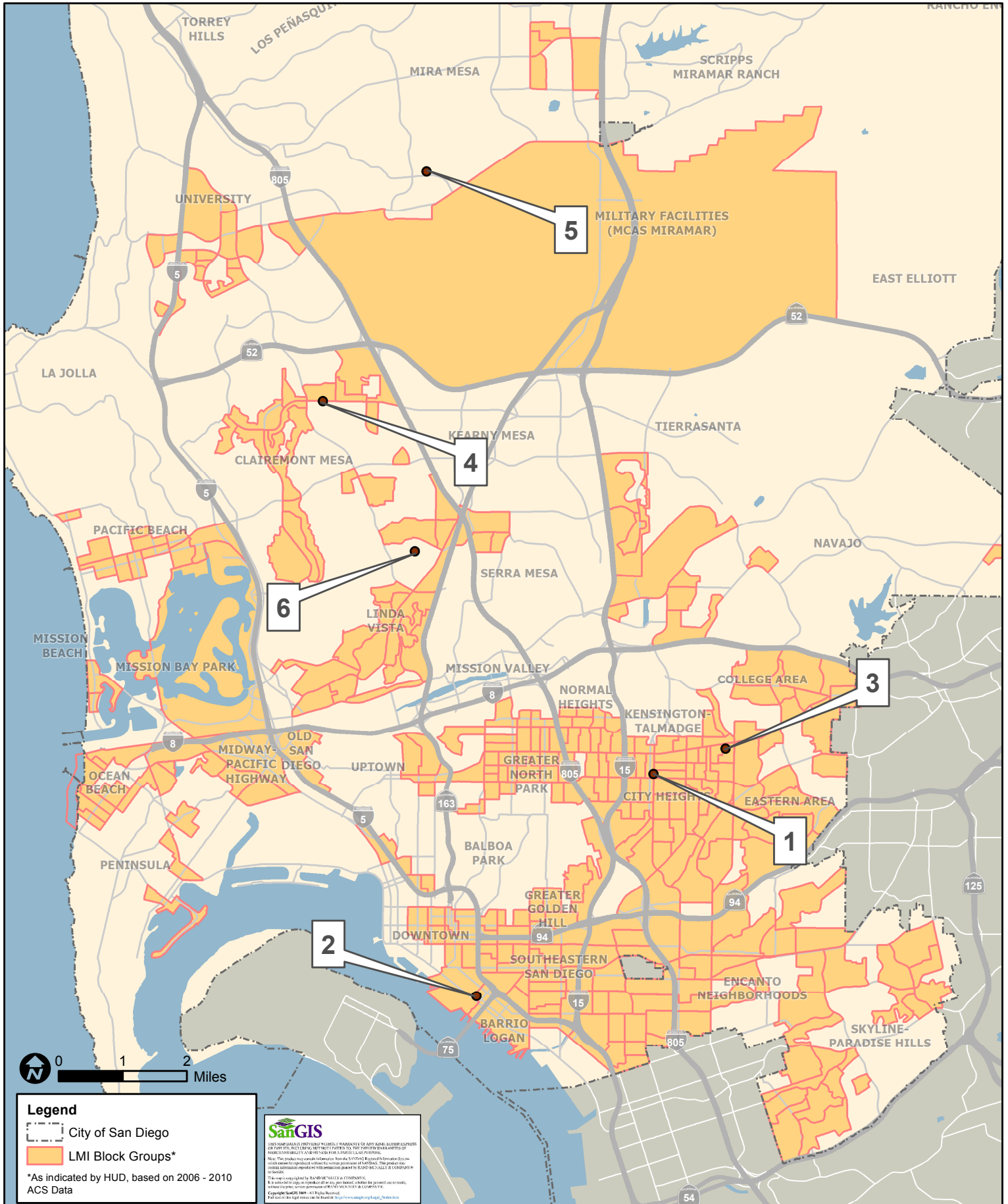

served more than 20 years of a 30-year prison sentence, "for participating in a nonviolent drug conspiracy, his first and only offense, during a time when his family was facing financial hardship." FAMM officials noted in a press release.

The release continued, "During his time in prison, Bond has maintained a perfect disciplinary record, earned outstanding work reviews, taken numerous classes, and worked to maintain strong relationships with his children."

In a letter to Terry Barnes, one of the prisoners granted clemency last week, President Obama wrote that the power to grant pardons and commutations embodies the basic belief in our democracy that people deserve a second chance after having made a mistake in their lives that led to a conviction under our laws. The president also reminded Barnes that he had the capacity to make good choices, even in the face of setback and people that question whether or not he can change.

"By making good choices, the president said, that Barnes would not only affect his life and those closest to him, but also the possibility that others in his circumstance could get the same second chance that Barnes received."

"We hope and expect to see more commutations granted" through the end of his term," said Stewart.

Bomberry said that if you look back at history, there haven't been many other presidents to grant clemency in this way, noting that the president's most recent order more than doubled the number of sentences commuted to President George W. Bush who only commuted 11 sentences during his two terms in the White House.

Summary of citizen participation process/Efforts made to broaden citizen participation.

Summarize citizen participation process and how it impacted goal-setting.

City staff continues to work with the Consolidated Plan Advisory Board (CPAB) to increase citizen participation and improve the FY 2016 CDBG application and evaluation process. Established in 2011, the Consolidated Plan Advisory Board (CPAB) serves in an advisory capacity to the Mayor and City Council on policy issues related to the Consolidated Plan and allocation of CDBG funds. During FY 2015 the CPAB has met a total of seven times. All the meetings are open to the public and agendas are distributed via e-mail, internet posting, and hardcopy posting. Meeting notes summarizing the discussion items and actions taken are posted online and made available at subsequent meetings to keep interested parties informed. The CPAB meetings provide a forum for citizens to participate in matters related to the Consolidated Plan and its implementation. The CPAB meetings also allow staff to vet policy issues and obtain public feedback.

In addition to the CPAB process, the City and/or its partner agencies (the Housing Commission and the County) engage and receive feedback from the public and other community stakeholders regarding the implementation of its HUD-funded programs through active participation in various collaborations and public bodies, such as the Regional Continuum of Care Council (on homelessness), the Joint City/County HIV Housing Committee, the San Diego HIV Health Services Planning Council, the City Council's Public Safety and Livable Neighborhoods Committee (PS&LN), and the Board of the San Diego Housing Commission. See below for details regarding the processes by which CDBG, ESG, HOME and CDBG funds are allocated and how the public is involved in each allocation process. It is through the allocations that the City seeks to advance the goals and objectives identified in the Consolidated Plan.

CDBG ALLOCATIONS

CDBG-Funded Application Process: The FY 2016 CDBG application process was divided into a two-step process. Initially, the City issued a Request for Qualifications (RFQ) that was available from October 27 through November 17, 2014. Fifty-nine (59) agencies responded to the RFQ and the City's HUD Programs Administration (HPA) staff reviewed these submittals for completeness and eligibility. As part of this process, one agency withdrew from the process and the remaining fifty-eight (58) agencies were deemed to meet all applicable requirements and possess the overall capacity needed to carry out eligible CDBG activities. Subsequent to the RFQ process, qualified agencies were invited to respond to the Request for Proposals (RFP) released by the City on January 5, 2015.

Forty-eight (48) agencies submitted proposals for projects and/or programs by the submittal deadline, January 26, 2015. A total of fifty-two (52) proposals were received, with a few of the respondent agencies submitting two (2) or more proposals. No late proposals were submitted. One proposal was immediately determined to be non-compliant with a mandatory workshop requirement (in accordance with City Council Policy 700-02).

HPA staff reviewed the remaining fifty-one (51) responses to the RFP for completeness and eligibility. Based upon the results of the review, a total of two responses were deemed ineligible due to the proposed activities described in their proposals. The remaining responses were forwarded to the CPAB (charged with reviewing and scoring applications and arrive at the project/programs recommended for funding) on February 5, 2015.

Prior to receipt of the RFP responses and during the CPAB January meeting, the CPAB had established three Ad Hoc committees for the purpose of discussing applications with one another and exchanging considerations. Each committee consisted of three CPAB members. HPA staff was in attendance and provided technical assistance at each meeting. Staff also reviewed the two portions of the application where an HPA scoring recommendation was provided. Each Ad Hoc Committee reviewed all applications. No group scores were developed and each reviewer was asked to complete their scoring forms independently. It is important to note that the City, working alongside board members and reporting on a regular basis to the public, had also recently made changes to the CDBG application review criteria used by the CPAB in line with applicable policies identified in the Con Plan. The revised criteria were applied to the FY 2016 CDBG applications for funding.

All CPAB members submitted their score sheets and returned the RFP applications to HPA staff by March 2, 2015. Funding recommendations were based on the highest scoring applications and funds available to fully fund requests. The averaged scores and subsequent funding recommendations were posted on the City's CDBG website and emailed to the HPA distribution list on March 6, 2015.

The CPAB unanimously ratified the scores and funding recommendations during their March 11, 2015 meeting. During the meeting, CPAB also discussed options for funding additional projects with the remaining balances for Community/Economic Development and Nonprofit Capital Improvement Projects categories. CPAB voted to combine the balances for these two categories (\$713,521) and recommend funding two other projects: (1) Direct Homeownership Assistance Project (Applicant: San Diego Housing Commission); and, (2) Installation of New Classroom Building (Applicant: San Diego Center for Children).

CDBG-Funded City Capital Improvement Projects (City CIPs): As noted in the Consolidated Plan, staff began working with CIPRAC in order to identify the most suitable projects. The process included public meetings, such as CPAB, Park and Recreation Board, City Council Infrastructure Committee and City Council at large, as well as presentation/discussions with CIPRAC.

As a result of this process, nine City CIPs are being funded with FY 16 CDBG entitlement funds as well as CDBG reprogrammed funds. The City CIPs will improve Park and Recreation facilities and install new walkways, traffic calming and traffic signal modifications in HUD qualified low and moderate income census block group areas. Each project application has been reviewed for HUD Programs eligibility, funding sources and project readiness.

It is important to note that a portion of the FY 2016 CDBG entitlement funds are set aside for the provision of homeless shelters and services. Per City Council Resolution No. 307701 (executed October 2, 2012), \$1,318,078 must be set aside "to assist in covering the expense of operating the Day Center Facility for Homeless Adults (henceforth referred to as the "Day Center for Homeless Adults" and formerly referred to as the Neil Good Day Center), Interim Housing for Homeless Adults (formerly the Veterans and Single Adult Emergency Winter Shelters), Cortez Hill Family Shelter, and Connections Housing Interim Bed Program, without any requirement of matching funds to the extent such funds are available each fiscal year and approved for such use by the City Council." This use of CDBG funds was also incorporated as a policy in the Consolidated Plan.

Funds are also allocated for administration and Fair Housing activities in accordance with City Council Policy 700-02. These funds are deducted from the City's overall annual CDBG budget prior to funding being made available to address other Consolidated Plan goals.

HOME ALLOCATIONS

The approval to use HOME funds in a manner consistent with the goals and objectives of the Con Plan continues to be granted by a 7-member Housing Commission Board of Commissioners and by the City Council acting as the Housing Authority of the City. The process for determining which activities are funded, and the amount of funding for each activity type, is based on needs and priorities as outlined in the Con Plan; input from the community during public hearings and other meetings; budgetary considerations; discussions with City Council and Mayoral staff; and overall economic conditions affecting the City.

The program's intentions and activities are communicated through a series of regular meetings with the development community and social service providers, and by participating in local, regional, and national housing events. The Housing Commission releases Notices of Funding Availability (NOFAs) to solicit project proposals that are consistent with the Con Plan's goals and objectives and the HOME program's requirements. Additionally, staff from the Housing Commission and City meet on a regular basis in order to ensure coordination among both agencies as well as conformance with the Consolidated Plan.

ESG ALLOCATIONS

The City, primarily through the Housing Commission, continues to be an active member of the Regional Continuum of Care Council (RCCC). The RCCC is a large, cooperative community group consisting of representatives of the 18 cities within San Diego County, the County of San Diego, non-profit service providers, and other interested parties. It meets monthly to identify gaps in homeless services, establish funding priorities, coordinate the submittal of applications for funding, and pursue an overall systemic approach to addressing homelessness in the San Diego region. Participation in this forum ensures that the City's efforts to address homelessness using ESG funds and other federal, state, and local resources

are coordinated regionally, respond to the most critical needs, and take into consideration input from the public and other homeless advocates.

HOPWA ALLOCATIONS

It is the policy of the County of San Diego to ensure adequate citizen involvement in the planning, implementation, and evaluation of its housing and community development programs. HOPWA program staff work diligently with community-based organizations, government agencies, and developers to establish adequate housing and support services for people living with HIV/AIDS. Program staff continues to maintain a permanent seat on the San Diego HIV Health Services Planning Council, responsible for planning services for people living with HIV/AIDS in San Diego and for allocating funding for these services. The Planning Council meets once monthly and all meetings are open to the public.

In addition, HOPWA program staff continues to be actively engaged in the Joint City/County HIV Housing Committee. The HIV Housing Committee includes members of other HIV planning groups, affordable housing developers, service providers, and consumers. It provides meaningful citizen and community participation in the planning process associated with affordable housing and related support services for persons living with HIV/AIDS. The Joint City/County HIV Housing Committee services as an advisory body to the director of the San Diego County Department of Housing and Community Development (HCD) regarding priorities and needs of the community affected by HIV/AIDS and housing. The Joint City/County HIV Housing Committee meets every other month, and all meetings are open to the public.

HOPWA funds are disbursed through a Request for Proposals (RFP) process. Contracts are typically awarded for one year with two 1-year renewal options. Contracts are renewed based on the agency's performance and the availability of funds. Funding is directed to agencies providing eligible activities that benefit persons living with HIV/AIDS and meet the Con Plan's goals and objectives.

Final FY 2016 Allocations: The City Council took action to appropriate and expend the FY 2016 CDBG, HOME, ESG and HOPWA monies to fund the programs and projects identified in this Action Plan during a public hearing which took place on March 24, 2015.
