<p>Quarterly Activities/ Project Description</p> <p>City of San Diego Community Development Block Grant - Recovery Program</p> <p>The goal of the City of San Diego CDBG-R Program during the quarter beginning April 1, 2010 and ending June 30, 2010 was to make final payment and complete final administrative tasks for two CDBG-R funded affordable housing rehabilitation projects, to complete design and start construction on the Montgomery Waller Recreation Center ADA Improvements project, and to select a qualified construction contractor for the Mt. Hope Market Street Median and Street Lights public infrastructure project. The City of San Diego was not able to complete the final administrative tasks and make final payment on the Euclid Court Apartments and San Diego Apartments projects due to administrative delays on the part of the City's subrecipient; however, these administrative tasks will be completed early in the next quarter. Design for the Montgomery Waller Recreation Center ADA Improvements project has been 90% completed and construction has commenced. The City received and opened bids for the Mt.
