Subject	:	Appointments to the Old Town San Diego Planned District Design Review Board

It is my pleasure to appoint Patrick Edinger, David McGwire and John Patterson to the Old Town San Diego Planned District Design Review Board, subject to your confirmation.

Patrick Edinger has spent 40 years in the planning, design and architecture field. He has won numerous awards as an architect, including the Gold Nugget Award and Consultant of the Year. He owns Edinger Associates where he specializes in site development and project design for custom homes and private communities. He is also a member of the American Institute of Architects, the National Council of Architects Review Board, the Building Industry Association and Home Building Council. Mr. Edinger was nominated by Councilmember Kevin Faulconer and fulfills the requirements for both the property owner and architect categories of the board. He will replace Paul Johnson, who resigned, for a term expiring March 1, 2014.

David McGwire is co-owner of Bailey & McGuire Pottery, Inc., which has three stores located in Old Town. Mr. McGwire has served on numerous committees associated with Old Town, including the Old Town Chamber of Commerce Board of Directors. He also served as Chair of the Old Town San Diego Chamber of Commerce Design Committee. Mr. McGwire has been a resident of San Diego for over 30 years and was nominated by Councilmember Kevin Faulconer. He fulfills the business licensee category requirements of the board and will replace Cynthia Furlong, who is termed out, for a term expiring March 1, 2011.

John Patterson has worked in landscape architecture, planning and design for over two decades and was involved in single and multi-family residential properties, urban mix-use and commercial/retail spaces. He is credited with a number of projects in San Diego, including Element in downtown and Escala Mission City Recreation Center in Mission

Valley. He is a member of the Urban Land Institute, the Building Industry Association and the Builder's Resource Council. Mr. Patterson was nominated by Councilmember Kevin Faulconer and is replacing Doug Livingston, who is termed out, for a term expiring March 1, 2013. Mr. Patterson meets the requirements necessary for the architect category.

I ask that you confirm these appointments and join me in acknowledging Mr. Edinger, Mr. McGwire and Mr. Patterson for their willingness to give their time and expertise to serve Old Town.
