

To the Hon. the Board of Trustees of the  
City of San Diego, California;

In the matter of taking  
a census of the inhabitants of the City of San  
Diego, Cal., I respectfully report as follows;—  
That under the provisions of Ordinance No.  
57 of said City, passed & on Nov. 8th. 1887, I did  
on March 9th. 1887 proceed to make, and have  
made an enumeration of the inhabitants of  
the City of San Diego, that said enumeration  
and Census so completed by me shows the  
number of inhabitants of said City to be  
Eleven Thousand Three Hundred <sup>and</sup> Seven  
(11,307). That to facilitate the work and com-  
plete the same within the time required, I  
districted the City into fourteen districts  
and assigned an assistant to each District,  
who canvassed and made enumeration  
of the inhabitants of his respective District,  
and returned the same to <sup>me</sup> which are  
here with filed. Said Districts are bounded  
as follows, and the resident inhabitants of  
each District are in number as follows;—

1st. District (1701 inhabitants) bounded on the North  
by "D" Street; E. by 7th St., = South by Bay = W. by 4th Street.

2nd District (1361 inhabitants) bounded on North by  
D St. = East by 4th. St = S. by Bay = W. by Front Street. —

3rd District, (675 inhabitants) bounded on North by

3rd Dist. = E. by Front St = S. by Bay = W. by Bay  
4th Dist. (1571 inhabitants) bounded on  
North by 2nd Street = E. by 11th Street = W. by <sup>4th</sup> 7th Street  
S. by N Street.

5th Dist. (889 inhabitants) bounded on North  
by Date Street = E. by 11th Street = S. by 2nd Street, ~~South~~  
West by 5th Street.

6th Dist. (872 inhabitants) bounded on North by  
Cedar Street = E. by 5th St = S. by 2nd St = West by  
Front Street.

7th Dist. (567 inhabitants) bounded on North by  
Cedar Street = E. by Front St = S. by 2nd St = W. by Bay.

8th Dist. (236 inhabitants) bounded on North by  
Laurel St = E. by 1st St = S. by Cedar St = W. by Bay.

9th Dist. (366 inhabitants) bounded on North by  
North line Horton's Add = E. by Park = West by 1st  
Street to ~~Laurel~~ <sup>Laurel</sup> St and from thence North by line  
of Middletown; on South from 5th St to 1st, and from  
1st to Middletown line by ~~Laurel~~ <sup>by Cedar St</sup> Street.

10th Dist. (1125 inhabitants) bounded on North by  
Park = on East by 15th St = on S. by N St = on West by <sup>14th</sup> 13th St.

11th Dist. (525 inhabitants) bounded on North by  
Park = on E. by 2nd St = S. by N St = W. by 15th St.

12th Dist. (549 inhabitants) bounded on North by N Street  
E. by Pueblo Line = on S. by Pueblo Line + Bay = on W. by Bay.

13th Dist. (226 inhabitants) bounded on North by ~~St.~~ line  
of Park extended to E. line Pueblo = on E. by Pueblo Line, on S. by  
N St. extended <sup>East</sup> to Pueblo Line = on West by 2nd Street.

14th Dist. (644 inhabitants) bounded on the  
North <sup>and</sup> East by the North and East lines of the  
Pueblo to the S.E. Cor. of Pueblo Lot 1349, on the South by  
a line drawn from S.E. Cor. of Lot 1349 <sup>Horton Street being</sup> to line of Middleton,  
thence ~~following~~ S. along Horton St. to Laurel St. thence W.  
along Laurel St. to the Bay, and thence following the bay  
shore <sup>line N.</sup> S. and W. to the South & West line of the Pueblo on  
Point Loma, <sup>to the coast of Pacific Ocean</sup> thence following the coast of the Pacific  
Ocean to the North point of the Pueblo. —
