Closing this beach during pupping season will protect seal mothers and newborn seal pups from human harassment. Unfortunately, harassment and encroachment from people often result in the seals flushing into the water, which causes them to expend energy needlessly while preventing them from gaining the benefits of hauling out. When pups are on the beach, they can be injured or even killed by stampeding adult seals.

Biologists have observed that the presence of people on the beach near the hauled out seals typically results in large numbers of seals flushing. An abandoned harbor seal pup cannot survive without its mother.
