Dear San Diego City Council,

Please support winter seasonal closure at Casa Beach during harbor seal pupping season, December 15 to May 15 annually.

Closing this beach during pupping season will protect seal mothers and newborn seal pups from human harassment. Unfortunately, harassment and encroachment from people often result in the seals flushing into the water, which causes them to expend energy needlessly while preventing them from gaining the benefits of hauling out. When pups are on the beach, they can be injured or even killed by stampeding adult seals.

Biologists have observed that the presence of people on the beach near the hauled out seals typically results in large numbers of seals flushing. By prohibiting the public from entering the beach, flushing incidents will be vastly reduced, thus preventing premature births, abandoned seal pups and increased pup mortality. An abandoned harbor seal pup cannot survive without its mother.

For all of these reasons, it is imperative that you vote to protect the La Jolla Seals by approving the seasonal closure of Casa Beach.

By prohibiting the public from entering the beach, flushing incidents will be vastly reduced, thus preventing premature births, abandoned seal pups and increased pup mortality. An abandoned harbor seal pup cannot survive without its mother.

When pups are on the beach, they can be injured or even killed by stampeding adult seals.

Biologists have observed that the presence of people on the beach near the seals typically results in large numbers of seals flushing. I have personally observed this flushing on MANY OCCASIONS, mostly caused by a group of people who do not believe that the seals should be at Casa Beach. They flush the seals daily and on the weekends they occupy the beach in protest. Every time they flush the seals, they harass the seals which is against the law (NOAA, MMPA, etc) and they also deprive all of the locals and tourists of the special experience they've come to Casa Beach to see.. the seals! I have lived in La Jolla for years and I have talked with A LOT of people at Casa Beach. They overwhelmingly love the experience of seeing the seals in their natural habitat.
