ITEM-200: Transfer Deferred Capital funds between Capital Improvement projects.

(Citywide.)

ITEM DESCRIPTION:

In 2008, the City issued approximately \$102.2 million in bond proceeds to address Phase I General Fund Deferred Capital (DC1) needs. DC1 funds were also used to initiate the design of a number of Deferred Maintenance projects. The construction phase of these projects were funded from the 2012 Lease Revenue Bond (DC2), which issued \$75 million in bond proceeds. The 2013A Bonds (DC2A) provided \$35 million for various projects. This action will transfer Deferred Capital funds in the amount of \$4,453,000 between Capital Improvement projects.

- 2. That the IBA provide options to fully fund and keep pace with capital needs and allow zero deterioration to assets;
- 3. That staff provide a list of pending projects by Assets Type and Priority Score.
- On February 29, 2012, Debt Management presented an informational report to the Budget and Finance Committee on the proposed Economic Refunding of the 2002 F&LS Bonds.
- On November 16, 2011, Debt Management presented an informational report to the Budget and Finance Committee on the Proposed 2012 Deferred CIP Bond Authorization.
