PROPOSITION A. CITY OF SAN DIEGO CHARTER AMENDMENT. AMENDS SECTION 219 OF THE CHARTER OF THE CITY OF SAN DIEGO.	YES	
Amends Section 219 to allow the leasing of certain Pueblo Lands North of the North line of the San Diego River for a period of time not to exceed fifty-five years instead of the fifteen-year limitation now in effect.	NO	

This proposition amends the Charter of The City of San Diego by amending Section 219. The portions to be deleted are printed in STRIKE-OUT TYPE and the portions to be added are underlined.

This proposition requires a majority vote.

Section 219. PUEBLO LANDS

No sale of Pueblo Lands owned by The City of San Diego which are situated North of the North line of the San Diego River shall ever be valid and binding upon said City unless such sale shall have been first authorized by an ordinance duly passed by the Council and thereafter ratified by the electors of The City of San Diego at any special or general municipal election. The City Manager shall have authority to lease Pueblo Lands, provided that any lease for a term exceeding one year shall not be valid unless first authorized by ordinance of the Council. No lease shall be valid for a period of time exceeding fifteen fifty five years.

ARGUMENT FOR PROPOSITION A

The purpose of Proposition A is to put certain City-owned lands to work which are now unproductive or under-productive because of lack of financing. A YES vote will serve that purpose by increasing the period of time these lands can be leased, to attract the financing.

Our Property Department reports that 872 acres will be affected. These are the last uncommitted remnants of the old Spanish land grant which established the City's "Pueblo Lands."

Under our 1931 Charter, the City is restricted from leasing these Pueblo Lands for more than 15 years. Proposition A will extend that limit to 55 years, which is the legal maximum for most other government owned land in California.

The 15 year leasing limitation condemns these lands to minor agricultural uses or to no use at all. Savings and loan institutions cannot grant loans for more than 5 years on a 15-year leasehold. Similar restrictive policies are practiced by banks and insurance companies.

As a result, these Pueblo Lands cannot be developed to their highest use because they cannot qualify for significant loans. The terms of most commercial loans range from 20 to 35 years. The effect is to deprive the City of revenues, and to deprive the public of the use of its own real estate.

This amendment will not in any way change the Charter's restriction on the <u>sale</u> of these Pueblo Lands. The Charter prohibits their sale except by voter approval. Proposition A will have no effect on that provision.

Under present City Council policy, surplus City-owned real property is normally leased instead of sold. The lease limit for City-owned land is 55 years, except for Pueblo Lands.

Proposition A will eliminate that exception, which has outlived its usefulness, and will put these 872 acres to work.

ARGUMENT AGAINST PROPOSITION A

VOTE "NO" ON PROPOSITION A

A lease for the period of fifty-five years removes use of the lands not only by the present generation, but also our children's and grandchildren's generations. A lease granted this year could tie up a valuable piece of property until the year 2030.

What today may seem like a wise lease to obtain funds from unused public lands may prove to be the unwise placing in bondage of valuable lands required fifteen years from now for parks, libraries, or other public facilities.

Except for apartments and other high density housing (which could become fifty year old slums), commercial leases run for ten or fifteen years, an adequate time for the leasee to amortise the costs of any structures that may be placed on the property. If the land were not required for public use, after 15 years, the lease could then be extended for another fifteen years.

On the other hand, if the land has been leased for 55 years, and it is required for public use in fifteen, too bad for our children and grandchildren.
