City's Budget: More Good News

The City of San Diego's financial picture continues to improve as revenue outpaces previous projections.

The larger budget surplus is translating into more money that can be used to restore and improve critical city services, which had been cut as San Diego struggled to regain its fiscal footing.

On May 23, Mayor Jerry Sanders presented his revised budget, recommending:

- An additional three hours a week at all city libraries on top of the five hours the city has already added.
- Increasing the number of police academy cadets

and holding more fire academies to train additional first responders.

- Investing an additional \$8.3 million into infrastructure projects such as street resurfacing.
- Upping our investment in arts and culture programs to improve our quality of life and boost our local economy.

The Mayor praised those on the City Council such as Sherri who made the difficult decisions necessary to make San Diego's economic recovery possible.

"This Council has made some of the toughest decisions it's ever had to make," said



San Diego now has a budget surplus.

Mayor Sanders. "It has had to make tough decisions over and over and over again."

Sherri knows there is much more to do but is proud that San Diego is on the right track.

"Through hard work and sacrifice, San Diego has turned the corner," Sherri said. "Together we will finish what we started."

Task Force to Tackle San Diego's Long-term Water Needs

The City Council approved a new task force on May 22, which will put into action recommendations detailed in Sherri's Comprehensive Water Policy.

The Comprehensive Water Policy, which the San Diego City Council unanimously approved last October, is a cohesive strategy to meet San

Diego's long-term water needs goals, timelines and measureby reforming rate structures, developing incentives for conservation and embracing cutting-edge technologies such as lose focus or momentum," advanced water treatment.

The 11-member task force, which includes representatives going forward, which is critical from a wide range of backgrounds, will develop specific

ments of success.

"This issue is too important to Sherri said. "This task force will help ensure that we have a sustainable water supply both to San Diego's economy and quality of life."

New Reforms, Less Red Tape for Small Businesses



Sherri helped celebrate "Small Business Week" by highlighting the city's progress in cutting red tape and announcing new initiatives designed to help local companies.

To celebrate "Small Business Week," Sherri joined her Council colleagues, industry leaders and small business owners on May 23 to highlight ways the city is helping local companies grow and create jobs.

As part of a "Regulatory Relief" workshop last fall, the public offered more than 60 ideas on how to cut red tape at City Hall. Since then, more than half of those suggestions have been implemented or are in the process of being implemented. As chair of the Economic Devel-

"We didn't just file all those suggestions in a drawer." Sherri said. "We took them seriously and are working hard to put them into action."

Sherri also announced a new email address, <u>regre-</u> <u>liefsd@sandiego.gov</u>, where the public can send their suggestions on how to make the city more efficient.

Sherri also unveiled several new initiatives designed to help small businesses thrive. They include:

- Creating satellite, after-hour building permit reviews, making it more convenient to get projects approved.
- Streamlining the permitting process for restaurateurs so that it takes less time to open a new eatery.
- Adding economic development staff to further assist local businesses.

Update: One Paseo

More than 200 people came to the Carmel Valley Community Planning Board meeting on May 24 to give their input on the One Paseo project.

Sherri helped arrange for the meeting to be held at Carmel Valley Middle School so there would be enough room for everyone to participate in the community process.

Sherri and community represen-

tatives on the Planning Board listened to almost three hours of testimony by the public.

The feedback provided at the meeting will be included in the Carmel Valley Community Planning Board's comment letter to the city on the draft environmental impact report for the One Paseo project.

Although Sherri is frequently asked to weigh-in on develop-

ment projects during the approval process, <u>by law</u> councilmembers must remain neutral until a project is heard at City Council. If Sherri were to state an opinion, she would be unable to vote on the project when it comes before the City Council.
