City's Credit Rating Continues to Improve

As further evidence of San Diego's ongoing financial recovery, Standard & Poor's raised the city's credit rating by two notches from A+ to AA-.

Standard & Poor's said the improved credit rating was the result of "strong financial management practices" and that the city has put in place improvements that will contribute to "continued transparency, timeliness, and accuracy of its financial statements."

The credit agency also boosted the city's rating for its long-term bond from A- to A+. far cry from the mid-2000s when the city's short-sighted decision to underfund its pension liabilities meant its credit rating was suspended, and the city was locked out of the bond market.

"Your credit rating doesn't go up if you are doing something wrong," Sherri said. "This shows that all the hard work, fiscal discipline and sacrifice of the last few years are paying off."

Higher credit ratings translate into lower interest rates, so it is less expensive to borrow money for much-need infrastructure projects.

While Standard & Poor's praised the city's healthy

financial reserves, Sherri said it is no time to get complacent or go on a spending spree.

"We need to continue to enact pension reform and managed competition so we can assure our financial stability while responsibly restoring services and improving our infrastructure," she said.

\$75 Million For Street Repaving and Infrastructure

On April 9, the City Council unanimously approved an investment of \$75 million to improve San Diego's infrastructure—from roads to storm drains to fire stations and libraries.

The City will issue bonds, with

\$30 million of the funds raised going to another round of road resurfacing.

The plan also calls for:

- \$15.5 million for storm water repairs
- \$16.3 million for upgrades to fire stations,

libraries and other facilities

- \$2.5 million for streetlight improvements
- \$1.5 million for park and recreation upgrades
- \$8.2 million for Americans with Disabilities Act improvements

Update: Save the Historic La Jolla Post Office



More than 400 people met with U.S. Postal Service representatives to express their concerns about the potential sale and relocation of the Wall Street post office. On April 26, Sherri joined more than 400 concerned citizens to meet with U.S. Postal Service representatives to discuss the fate of the historic post office in the heart of La Jolla's downtown Village.

Earlier this year, the Postal Service announced it planned to close and sell the post office on Wall Street to help bolster the Postal Service's bottom line.

During the productive discussion, U.S. Postal Service representatives expressed a willingness to work with the community on possible alternatives to the proposed sale.

Diana Alvarado, regional property manager for the Postal Service, said her organization was undergoing a 90-day study and had hired a historical consultant.

Sherri applauded the community's civic involvement and pledged to continue working to find a solution that makes sense for everyone. "Whatever solution we come up with has to benefit both the community and the Postal Service," Sherri said. "The most important thing is to keep the lines of communication open."

Focus on the Arts and Culture Economy

The impact of arts and culture on San Diego's economy was front and center at the April meeting of the Economic Development and Strategies Committee, which Sherri chairs.

Victoria Hamilton, executive director of the San Diego Arts Commission, provided an overview of the economic benefits that its targeted funding program has brought to San Diego.

According to its analysis, 68 arts and culture organizations employ 6,000 workers, generating \$170 million in direct local spending and attracting more than 2 million visitors a year.

The Carmel Valley Community Planning Board will hold a meeting on Thursday, May 24 at 7 p.m. to discuss its proposed comment letter to the city.

Although Sherri is frequently asked to weigh-in on projects during the approval process, by <u>law</u> councilmembers must remain neutral until a project is heard at City Council.

Sherri Around Town in April





Helping constituents get potholes filled, streetlights fixed and other neighborhood repairs is one of Sherri's top priorities. Here is a sampling of projects her office worked on this past month:

Potholes:

- Right-hand turn lane on Torrey Pines Road to La Jolla Village Drive
- La Jolla Colony Drive, from I-5 to Palmilla Drive
- Westbound La Jolla Parkway, right-hand lane, just past the La Jolla Scenic Drive North off-ramp

Cleanups and Repair:

• Weeds sprayed and litter

removed along sidewalk of northbound Torrey Pines Road from Glenbrook Way to La Jolla Village Drive

- Damaged asphalt repaired in bike lane on southbound Genesee Avenue, just south of La Jolla Village Drive
- Street sweeping throughout Torrey Hills, including Senda Luna Llena, Via Mar de Delfinas and Gracewood Place
- Water leak repaired on eastbound Governor Drive at Erlanger Street
- Irrigation leak fixed at Durango Drive and Del Mar


Heights Road
