CITY COUNCIL ACTIONS:

On Monday September 17, 2007 the San Diego City Council conducted a financial training workshop designed to assist the Council members with keeping updated on the many complex financial documents and related materials used for decision making. This training is one of several prongs in our multi-pronged approach to restoring our city to a viable fiscal condition and improving our abilities to make sound fiscal decisions.

On Tuesday September 18, 2007 the San Diego City Council unanimously approved a grant application for \$200,000 from the Office of Juvenile Justice and Delinquency Prevention to help coordinate gang prevention and intervention activities in the 4th District community of Encanto. I commend and thank the Commission on Gang Prevention and Intervention for their continuing efforts to bring resources to this city. This is but one action in the many actions they



are currently taking to bring resources to various communities throughout the city that are impacted by gangs and gang activity. We look forward to approving similar recommendations that provide gang prevention and intervention services in all Council Districts.

On Thursday, September 20, 2007 in my position as Co-Chairman of the San Diego City/County Reinvestment Task Force, I launched the Task Force's "Foreclosure Prevention and Intervention Initiative." Results of our efforts to examine the range and impacts of the current home foreclosure crisis, its impacts on low and moderate income communities, and actions that we can take as a City and County to respond to this foreclosure crisis were presented at the Task's Force's monthly meeting. Recommendations include: Pro-active efforts from City and County agencies to assist San Diego homeowners in avoiding losing their homes to foreclosure, securing additional funding for foreclosure prevention counseling, education and outreach services; strong code enforcement on properties that are absentee owned and vacant, and increasing efforts by the City Attorney, district Attorney, county Counsel and other law enforcement agencies to investigate fraud and misleading activities that have contributed to this crisis in foreclosures.

This is a critical issue for our communities. The proliferation of sub-prime loans and the increase of foreclosed properties represent a threat to the quality of life in our neighborhoods. I am very concerned about the economic well being of our residents due to the fact that this crisis severely impacts the very soul and existence of our citizens and our communities. I thank the members of the Task Force for their outstanding efforts in working on these recommendations and helping set an example for cities throughout this nation that are experiencing this national crisis. We will be bringing the recommendations to the full City Council in the next few weeks.

- **On August 4, 2007 a community clean-up was held in the 4th District community of Broadway Heights.** A total of 47.52 tons of waste was collected, 38.71 tons of non-recyclables and 8.81 tons of recyclable materials consisting of metals and appliances was collected. - **On August 8, 2007 a community clean-up was held in the 4th District community of Skyline.** A total of 5.78 tons of waste, 3.95 tons of non-recyclables and 1.83 tons were recyclable materials consisting of metals and appliances were collected. Ms. Edwina Hardieway, community members and the City of San Diego's Environmental Services Department, are commended for their assistance and support.
- **On August 11, 2007 the Black Police Officers Association conducted a major clean-up at 50th and Imperial Ave.** EDCO Waste and Recycling Services donated 1-40 cubic yard "Roll-off" boxes for this much needed clean-up. I commend and thank the Black Police Officers Association and EDCO Waste and Recycling Services for their outstanding contributions toward helping keep our communities clean and safe.
