Community Clean-ups are continuing to be held throughout the 4th District. I commend, thank, and congratulate the many community volunteers, city staff, non-profit organizations and EDCO Waste & Recycling Services that assist in these efforts. Keeping our communities clean and free of debris is an ongoing effort we all must continue to be involved in.

On November 17, 2007, we held an Auto Product Recycling event at the School of Creative and Performing Arts. At this successful event we collected more than 10,700 pounds of recyclable hazardous waste including 620 gallons of used motor oil; 4,300 pounds of automotive batteries; 91 pounds of oil filters; and 80 gallons of antifreeze.



On December 6, 2007 a community clean-up was held in the 4th District community of Mountain View. This clean-up removed a total of 6.88 tons of waste (5.74 of non-recyclables and 1.14 tons of recyclables) from the neighborhood. Members of the Mountain View community and the City of San Diego's Environmental Services Department, are commended for their assistance and support.

On Each year the City of San Diego's Environment Services Department conducts special community cleanup events in neighborhoods throughout the City. Areas are selected for these events based upon citizen request, pledges of community involvement and previous citizen participation levels.
