RE: CITY PROCESS FOR APPEALING PERMITS AND ENVIRONMENTAL DOCUMENTS

Dear Chairwoman Frye and Council Members:

The San Diego Sierra Club would appreciate the opportunity to bring to the GE&O committee for review the process currently being used by San Diego Development Services and Planning Departments for appeal of environmental documents to the City's highest elected officials, namely, the City Council. Our concern with the City process stems from the Sierra Club's experience in the appeal of a Hearing Officer decision to Planning Commission April 7, 2005 (Attachment 1, Item 10, Salk Institute Geotechnical Investigations- Project No. 54535).

Three business days after the April 7, 2005, Commission hearing, we discovered by chance that the City had already sent a Notice of Final Action (NOFA) on the project to the California Coastal Commission. This Notice was posted in the Coastal Commission office April 12, thus opening the Coastal Commission 14 day appeal period (Attachment 2). How can the appeal period on project permits terminate prior to review and final action on the environmental document by City Council?

Please note that it was not stated in Planning Commission documents, at the hearing itself, or in the NOFA posted at the Coastal Commission office what we were later told by Robert Manis from Planning, namely, that because the project's Coastal Development and Site Development permits were not appealable to Council, they became final the day the Planning Commission voted (April 7), even though there were 10 days remaining beyond the posting of the NOFA for public appeal of the MND. It was disturbing to be told that the City is "working on" this process, which has yet to go through any public review and/or certification process.

City Environmental Appeal Process Page 2 July 29, 2005

We raised these concerns to Planning Commission during Public Comment on June 30, 2005, with no response to date from staff or the Commission. Events to date have raised what we believe are likely errors in noticing and procedure, as well as improper project segmentation under CEQA. Substantively, there would have been no holdup for the applicant to await MND review by City Council, since, as submitted for the record by biologist Vincent Scheidt, no drilling could go forward between February-August without violating the federal Migratory Bird Treaty Act and the CA Fish and Game Code.
