ITEM-6:       **SPRINT CREEKSIDE - PROJECT NO. 244540**  
City Council District: 4; Plan Area: Encanto

Conditional Use Permit and Site Development Permit (consolidated Process 3) for an existing Wireless Communication Facility (WCF) consisting of nine antennas on a 30-foot tall monopalm. The monopalm has been designed and configured so that the existing fronds extend a minimum of 24 inches in front of the panel antennas. A total of 70 fronds were installed as part of the original approval, appropriately screening the antennas and the associated mounting brackets. Sprint is proposing to remove all vacant and unused mounting pipes from the monopalm. The equipment associated with this WCF is located inside a 240-square foot CMU enclosure with a chain link lid and will continue to operate without any modifications. The facility is located at 220 47<sup>th</sup> Street in the Southeastern San Diego Planned District MF-3000 zone within the Encanto Community Planning Area and Council District 4.
