Subject matter and time limitations are noted on the form. Pursuant to open meeting laws, no discussion or action, other than a referral, shall be taken by the Committee on any issue brought forth under "Public Comment."

REQUESTS FOR CONTINUANCE: Members of the public may request an item be postponed or rescheduled by submitting prior to the meeting a "Request to Speak" form and asking that the matter be "continued." The decision whether to continue the matter is at the Board's discretion.

CONSENT AGENDA: The Chair may entertain a motion by a Board Member to approve certain non-controversial agenda items as consent agenda items at the beginning of the meeting.
