**Attention: San Diego Regional Enterprise Zone (SDREZ) Program clients**

Effective 5:00PM on October 1, 2014, the City of San Diego will no longer be accepting EZ tax credit voucher applications for processing. Any applications received after that deadline will be returned to the sender (i.e. business and/or consultant).

If you would like to proceed with the processing of EZ voucher applications submitted post-October 1, 2014 you may do so by contacting one of the following independent Third-Party vouchering agents that have been prequalified by the State's Housing and Community Development (HCD) Department to process tax credit voucher applications for qualified businesses located within the SDREZ:

For the **San Diego** portion of the zone, the Kings County Economic Development Corporation has been designated by HCD as Third-Party Agent assigned to accept voucher applications, process and issue Hiring Tax Credit voucher certificates. Their contact information is:
