ACCESS FOR PEOPLE WITH DISABILITIES: This information will be made available in alternative formats upon request. To request an agenda in an alternative format or to request a sign language or oral interpreter for the meeting, call the City Clerk (533-4000-voice or 236-7012-TT) at least five working days prior to the meeting to ensure availability. Assistive Listening Devices (ALDs) are available from the City Clerk's Office prior to the meeting, and are to be returned at the end of the meeting.

NON-AGENDA PUBLIC COMMENT: Any member of the public may address the Task Force on any subject in its area of responsibility on any matter not presently pending or previously discussed at the Task Force. Comments are limited to three (3) minutes and are non-debatable. At the conclusion of the comment, the Task Force Chair shall have the discretion to determine appropriate disposition of the matter. To exercise this right, members of the public wishing to address the Task Force during the Public Comment portion of the meeting, must submit a Public Comment Request slip prior to the meeting. Subject matter and time limitations are noted on the form. Pursuant to open meeting laws, no discussion or action, other than a referral, shall be taken by the Task Force on any issue brought forth during the Public Comment portion of the meeting.

REQUESTS FOR CONTINUANCE: Members of the public may request an item be postponed or rescheduled by submitting prior to the meeting a "Request to Speak" form and asking that the matter be "continued." The decision whether to continue the matter is at the Council's discretion.

CONSENT AGENDA: The Chair may entertain a motion by a Task Force Member to approve certain noncontroversial agenda items as consent agenda items at the beginning of the meeting.
