ETHICS COMMISSION ANNOUNCES SETTLEMENTS WITH CITY OFFICIALS CONCERNING ECONOMIC INTEREST DISCLOSURE REQUIREMENTS

The San Diego Ethics Commission announced today that it has taken action to enforce the economic interest disclosure requirements set forth in the Ethics Ordinance. The Commission voted unanimously to approve settlement agreements with the following City Officials who have agreed to pay a fine in connection with the late filing of their Statements of Economic Interests:

- Thomas Anglewicz, a consultant with the Centre City Development Corporation
- Michelle Butler, member of the San Diego Regional Revolving Loan Fund
- Paul Johnson, member of the Historical Resources Board and the Old Town San Diego Planned
 District Design Review Board
- Louay Yousif, member of the Centre City Advisory Committee

With the exception of Paul Johnson, each of above-referenced officials paid a fine in the amount of \$200 for failing to timely file an annual Statement of Economic Interests for calendar year 2007. Mr. Johnson paid a fine in the amount of \$1,000 because he has a history of late filing, because he failed to timely file his Statement of Economic Interests as a member of two City boards, and because he was the subject of a prior enforcement action that resulted in a fine for his late filing of his 2005 annual Statement of Economic Interests. All of these settlement agreements were made by way of stipulations that can be viewed on the Commission's website at www.sandiego.gov/ethics.

The Ethics Ordinance requires all City Officials to file an annual Statement of Economic Interests disclosing their investments, interests in real property, loans, gifts, and sources of income that could potentially present a conflict of interest when participating in municipal decisions. According to the Commission's Executive Director Stacey Fulhorst, "The disclosure of economic interests is one of the fundamental provisions of the Ethics Ordinance because it provides the transparency necessary to assure the public that City Officials are not influencing municipal decisions that could affect their personal economic interests." Annual Statements of Economic Interests are due on April 1 of each year. The City Clerk's Office contacts each filer well in advance of the filing deadline, and sends a follow-up notice if the Statement is not timely received.

Commission Chairman Gil Cabrera commented that, although the Commission is mindful of the invaluable service provided by the members of the City's Boards and Commissions, the requirements regarding economic interest disclosure "cannot be ignored simply because these City Officials are volunteers." Chairman Cabrera added that, with these enforcement actions, the Commission hopes to remind all City Officials that the timely filing of Statements of Economic Interests will be strictly enforced by the Commission.

Ethics Commission fines are paid to the City of San Diego's General Fund. The stipulated settlements approved by the Commission resolve all factual and legal issues without the necessity of holding an administrative hearing.
