



**Minutes for Meeting of

**Item-1: Call to Order**

Chairwoman Dorothy Smith called the meeting to order at 5:00 p.m.

**Item-2: Roll Call**

**Item-5: Commissioner Comment**

Chairwoman Smith acknowledged Dave James, and expressed appreciation for his service as legal advisor to the Ethics Commission. Chairwoman Smith further congratulated Mr. James on his impending retirement. Mr. James was presented a plaque in recognition of his service to the commission.

Mr. James thanked the commission and stated he was proud to have served the Ethics Commission as its legal counsel.

**Item-6: Executive Director Comment**

Director Fulhorst reported the following:

1. Completion of ethics training for the elected officials and their staff.
2. Finalization with the Data Processing Corporation of the on-line recertification training program. The Commission will be asked to test the new system when completed.
3. A live , ethics training will be conducted for the City Manager and Department heads.
4. Preparation on FY 2006 budget. Budget priorities:
  - A. Increase Financial Investigator position from  $\frac{3}{4}$ - to full-time.
  - B. Possible adjustment to part-time legal counsel position or addition of new staff position.
5. Audit Ad Hoc Subcommittee will bring its proposed amendments to the Audit Manual to the Commission's March 10, 2005, meeting.
6. The proposed amendments to the Audit Manual will be presented at the Rules Committee meeting of April 6, 2005. A discussion of Council Policy 300-11 will also be on the agenda.

**Item-7 General Counsel Comment**

**Item-8 Election Campaign Control Ordinance – Legal Defense Funds**

Director Fulhorst presented the memorandum dated February 3, 2005, regarding legal defense funds.

April Boling discussed the issue of multiple legal defense funds and the method to be used should donor contribution refunds be required. Ms. Boling also explained they are holding a great number of contributions until a decision is made as to whether the completion of a pending matter disclosure form perfects a contribution to the legal defense fund.

By consensus, the Commission directed the executive director to distribute one or more fact sheets regarding legal defense funds and the disclosure of pending matters, pursuant to the guidelines provided by the Commission.

**Item-9: Election Campaign Control Ordinance – Credit Card Vendors**

Director Fulhorst asked for Commission direction on the issue of requiring re-reporting of credit card vendors as intermediaries on campaign disclosure statements.

Motion: Commission not to require back reporting of credit card vendors as intermediaries.

**Item-10: Proposed Amendments to Operating Policies**

Director Fulhorst explained the proposed amendments related to the recent approval of independent counsel for the Ethics Commission.

**Item-11: Ethics Ordinance – Future Employment of City Officials**

Director Fulhorst asked for Commission direction regarding the provision in the Ethics Ordinance which prevents City Officials from negotiating future employment while working on municipal decisions that involve a prospective future employer. Although not specifically stated in the Ordinance, Director Fulhorst questioned whether it was the Commission’s intent to exclude public agencies from this provision.

Motion: Negotiation for future employment with other public agencies does not violate post employment restrictions covered under SDMC 27.3551.

Moved/Seconded: Leonard/Westfall

Vote: Unanimous
