Anticipated Litigation. Initiation of litigation pursuant to Government Code section 54956.9(d)(4) (11 potential matters: Case Nos. 2013-15 through 2013-17, 2013-25, 2013-26, 2013-45, 2014-01, 2014-14, 2014-26, 2014-27, and 2014-29). The Ethics Commission may meet in closed session to consider the settlement, dismissal, status of an investigation, or the issuance of a subpoena or Draft Administrative Complaint, with regard to an enforcement action against a person or persons alleged to have violated local governmental ethics laws. Should the issuance of a Draft Administrative Complaint be authorized, the identity of the Respondent or Respondents will be available after a Draft Administrative Complaint is issued and the matter is noticed for discussion as pending litigation.
