**Item-3: Administrative Hearing: In re the Matter of Luis Acle (Case No. 2006-59)**

The parties presented evidence and arguments in connection with the allegations in Petitioner's Final Administrative Complaint, followed by the deliberation of the Commission. Pursuant to San Diego Municipal Code section 26.0436(e), the hearing was recorded. In addition, a Peterson & Associates court reporter made a record of the hearing.

Motion: Direct Petitioner to prepare a proposed Administrative Enforcement Order that outlines the Commission's findings and details the fines the Commission has imposed, and to include within the Order a requirement that within 60 days Respondent pay the debts owed to PAC Management & Consulting and Ann Kelsey, that within 30 days Respondent file all outstanding campaign reports and amend any inaccurate or incomplete campaign reports so that they are true and accurate, and that within 180 days Respondent pay the fine imposed by the Commission.

Moved/Seconded: Fuller/Biddle

Vote: Motion carried 5/2 with Commissioners Haney and Valdez voting nay

Commission Chairman Cabrera directed the Petitioner to prepare a proposed Administrative Enforcement Order for review by Commissioners Cabrera, Haney, and Valdez. Chairman Cabrera indicated that he would sign the final Administrative Enforcement Order on behalf of the Commission.
