

Citywide Program Expenditures



Description

The Citywide Program Expenditures budget is comprised of various programs and activities that provide benefits and services citywide. The General Fund portion of programs or activities whose funding is divided among the General Fund and the Non-General funds, and/or programs or activities that are generally not attributable to any one City department are allocated to this budget. The Citywide Program Expenditure budget is administered by the Financial Management Department with input from responsible departments throughout the City.

Part of the Citywide Program Expenditures budget includes activities of the Redistricting Commission. The Commission will develop and adopt plans that specify the boundaries of districts for the City Council, which are required to be redistricted at least once in every ten years (City Charter Article II, section 5.1). The redistricting plan is intended to provide fair and effective representation for all citizens of the City, including racial, ethnic, and language minorities, and be in conformance with the requirements of the United States Constitution and federal statutes.

Unique to this cycle, in response to a vote of the people to amend the City Charter, the Commission is tasked with creating a redistricting plan that adds a ninth Council district. The Commission is also conducting its work on a significantly shorter timeline than is provided for in the City Charter in order to comply with deadlines provided by the San Diego County Registrar of Voters.

The Commission has taken extensive steps to identify cost savings and maximize efficiency, including in its hiring of Commission staff and outside technical consultants and services; use of City staff and resources; Commission administration and operations; and community outreach efforts. The allocation in the Fiscal Year 2012 proposed budget reflects this effort. However, given the unique challenges and time constraints associated with this redistricting cycle, the Commission understands that the City Council shall appropriate funds to the Commission and to the City Clerk that are adequate to carry out their duties as specified in the City Charter (City Charter Article II, section 5.1).
