Goal 2--Develop joint partnerships to help address gang issues within the City of San Diego.

# Ad Hoc Update

The **Safe School Zones Ad Hoc** continues it work under the leadership of Chief Littlejohn and the San Diego Police Department. Principals from the six pilot schools (Bell Middle School, Montgomery Middle, Horace Mann, O'Farrell, Wilson Middle School and Clark Middle School) have become actively involved and will have a promotional action in May. Initiated by Horace Mann principal, Courtney Thompson, the action will be a neighborhood walk and engagement of local businesses within the 1,000 foot zone. Other schools are invited to participate in this initial kick off and there is a discussion about a fall event tied to walk to School Day.

### **Community Initiatives Update**

The Commission is working with **Jacobs Center's Graffiti Committee** on a curriculum and process for working with San Diego Police Department, StarPal and the Probation Department to educate youth involved in tagging and graffiti. The Graffiti committee is working with the Probation Department, the DA's office for an event this weekend at the Mission Valley Mall.

The **Community Assistance Support Team** (CAST) walked on South 35<sup>th</sup> street with Pastor Santos and his volunteers, and also walked through Casa Sierra (Imperial and 50<sup>th</sup>). KPBS covered the CAST events and interviewed Commissioner Bowser. The CAST team also had a phone conference with Oakland's Rev. Damita Davis Howard of the Oakland Night Walks. **Connect 2 Hope** a program supported by Councilperson Cole and facilitated through the Urban League, cleaned graffiti off of the Encanto Boys and Girls Club. Chair Lozada will be thanking them next week.

The Commission sent a support letter for the San Diego County office of Education's application for the funding of **Second Chance Act Technology Career Training Program for Incarcerated Adults and Juveniles** (CFDA 16.812)

The Commission supported the **NAACP's Trauma Informed Care event** on March 18<sup>th</sup>. Commissioner Dana Brown was on the panel. About 75 people were in attendance at the Malcolm X library.

The **County's Behavioral Health Agency** will be taking public input regarding Proposition 63, known as the Mental Health Services Act (MHSA or the Act),. Prop 63 was enacted on January 1, 2005. The MHSA imposes a one percent income tax on personal income in excess of \$1 million in order to increase funding, personnel, and other resources to expand service programs and monitor progress toward statewide goals for serving children, transitional age youth, adults, older adults, and families with mental health needs. In summary, Proposition 63:

- 1) Provides funds to counties to expand services and to develop innovative programs And integrated service plans for mentally ill children, adults and seniors.
- 2) Requires the State to develop mental health services programs including prevention, early intervention, education and training.
- 3) Creates a commission to approve certain county mental health programs and expenditures.

The MHSA requires that each county mental health program shall, with involvement of stakeholders, prepare and submit a three-year Program and Expenditure Plan for approval by the California Department of Mental Health (DMH).

#### **2014 Community Violence Prevention Summit Update:**

Attendees made connections with resources, initiatives and ideas. Our keynote speaker Julio Marcial, from The California Wellness Foundation was very much appreciated. Overall the team organizers (Anthony Ceja from County Office of Education, Grace Lui and JJ Anderson from the DA's office, Ian Gordon from Workforce Partnership, Agin Shaheed from San Diego Unified School District, Amelia Barile-Simone from HHSA and Gonzalo Mendoza from Probation) got kudos for the conference.
