Action Item 1:

According to a number of resources, pimping and other exploitative crimes are now the second biggest revenue source for gangs in San Diego County. Detective William Woods will present the current information on this problem.

Recommended Action: Establish an Ad Hoc Committee to research community strategies, parent training options and follow AB918 to assess the Commission's potential recommendation to the City to support the legislation. The Committee is tasked to report to the Commission at its July luncheon meeting.

Action Item 2:

The County's Health and Human Services Agency has been working on a 10 initiative. The Commission invited the Agency to talk about the Building Better Health Strategy at a fall commission meeting and set up an Ad Hoc Committee (StacyAdams for Commissioner Mack Jenkins-Probation), Commissioners Alicia Deleon Torres, Rosa Ana Lozada, and Scott Silverman) to work with their staff on areas of collaboration. Recommended Action: The Ad Hoc Committee recommends directing staff to report in September on continued collaboration with the County's Health and Human Services Agency and to include all Agency-Commission Collaboration efforts in reports to City Council.
