Action Item 1:

According to a number of resources, pimping and other exploitative crimes are now the second biggest revenue source for gangs in San Diego County. Detective William Woods will present the current information on this problem.

Recommended Action: Establish an Ad Hoc Committee to research existing community strategies, parent training opportunities and follow the local implementation of AB918 to identify recommendation(s) to the City to support the legislation. The Committee is tasked to report to the Commission at its July luncheon meeting.

Action Item 2:

The County's Health and Human Services Agency (HHSA) has been working on the Building Better Health Strategy, a 10 year strategy to impact health throughout the county. The Commission was invited by the HHSA to identify common goals and improve collaborative efforts to achieve those goals. At the November, 2010 Commission meeting, an Ad Hoc Committee (Stacy Adams for Commissioner Mack Jenkins-Probation), Commissioners Alicia Deleon Torres, Rosa Ana Lozada, and Scott Silverman) was established to work with HHSA staff. The following report and the attachments are the result of meetings, research and partnering for the past 7 months and next steps.

Recommended Action: The Ad Hoc Committee recommends that staff continue to work with the County and present an update at the September Commission meeting.
