COURSE TITLE: American Red Cross Emergency Response
(CPR for the Professional Rescuer included - 2008)

UNITS: 1.5

Course # FIPT 309A

Course Description: This 48-hour introductory course involves lecture and skills training for those individuals who have a duty to respond in emergency situations (first responders). Course involves training in knowledge and skills necessary to sustain life, reduce pain, and minimize the consequences of injury or sudden illness.

CERTIFICATION: Emergency Response certification valid for three years, CPR for the Professional Rescuer (valid for one year), AED Essentials (valid for one year), Oxygen Administration for the Professional Rescuer (valid for one year), and Preventing Disease Transmission (bloodborne pathogens). This course is consistent with the U.S. Department of Transportation (DOT) first responder curriculum and exceeds the requirements of the California Health and Safety Code (Title 22).

HOW TO ENROLL

Step 1 - APPLICATION AND ENROLLMENT

Step 2 - ATTEND COURSE

Attend first day of class. Books, pocket mask, certification, tuition, accident insurance, and health fees are due on the first day of class.
