Purpose of the Golf Enterprise Fund

 The purpose of the Enterprise Fund is to shelter the City General Fund from obligations or costs incurred by the Fund and ensure that assets are properly operated and maintained to sustain the long-term stability of the Enterprise Fund, while providing all golfers with a range of golfing opportunities at the best possible value.

Market Place Context

- The regional golf market has begun to show signs of mild recovery however, we believe that the market will continue to struggle and show only minimal recovery of the next several years
- The local golf market will continue to be very competitive with surplus supply and very slow growth in demand



Market Place Context (cont.)

- Increased competition will require each golf course to focus on providing the "best overall value" based on consistency of course conditions, facilities and customer service.
- Current market conditions require that each golf course develop and implement proactive marketing and customer loyalty programs.
- The Torrey Pines courses will continue to be in higher demand compared toother local courses and it will continue to generate significant revenue

Golf Division Objectives

- The primary users at all golf complexes are intended to be City of San Diego residents
- The Division supports local, national and international amateur golf (local Junior Golf, Junior World, High School, College, Men's and Women's Clubs and City Amateur tournaments and events)
- Continue to ensure City of San Diego resident availability to all City Golf Courses by utilizing tools such as restricting access to tee times by user type as needed
- Resident golf fees should be established considering the rates within the local market place, operational costs at each facility and long-term sustainability of the Enterprise Fund.
- Non-resident golf rates should be based on appropriate market rates.

- Environmental sustainability is a priority and all purchases, contracts and construction projects will consider and strive to utilize materials, equipment and procurement processes that support our desires to improve our environmental sustainability

- Water efficiency is a significant priority at each of our facilities and our irrigation schedules are based on Evaporation Transpiration
- Each of our facilities uses organic based fertilizers and alternative nutrient sources to balance soil and water chemistry, building sustainable soil structure for turfgrass plants to thrive with minimal use of chemicals
