5. **Location: Road Closure:** Our event will be based in De Anza Cove with a 5k run route and 1mi walk route heading out and looping back to the start/finish area. Road closure of Mission Bay Drive is requested during the time of the race only (with safety windows before & after). See more information in #8.
6. **Parking Lot Closure:** Access to/from the parking lot near the boat ramp and the two lots immediately south of that lot will be temporarily restricted during the approximately 30 minute window of the run. Event staff will open access to parking lots, as soon as possible/safe.
7. **Parking Plan: Shuttle Plan:** Our event should have ample parking between the two lots closest to De Anza Cove.
8. **Traffic Plan:** Temporary road closure requested from approximately 9am to 9:30am on 10/13/2012 of Mission Bay Drive from the park entrance near the golf course to just north of the Hilton. If the Committee prefers, traffic could be allowed into the park throughout the duration of our requested road closure and allowed to proceed north only, as our route would not be affected. If this is requested by the committee, appropriate traffic safety equipment will be provided. Similarly, if the committee requests, northbound traffic on Mission Bay Drive could be allowed throughout the duration of our event as we could limit the event to the southbound lane only. If this is requested, appropriate traffic safety equipment will be provided. Allowing traffic into the park and proceeding northbound will still allow for access to the golf course and will likewise prevent congestion from forming on Mission Bay Drive near the entrance to I-5. Allowing northbound traffic on Mission Bay Drive along our requested route will similarly alleviate congestion within the park.
