

Fiesta Island Youth Camp Rules and Regulations

1. The Fiesta Island Youth Camp IS LIMITED TO ORGANIZED YOUTH. A YOUTH GROUP IS A NONCOMMERCIAL ORGANIZATION. FAMILY CAMPING IS NOT PERMITTED.
2. CAMPING FEES: Please check the current Fee Schedule. Please make check or money order payable to: "City Treasurer."
3. Adult supervision (18+ years of age) is required at a minimum ratio of one (1) ADULT for every five (5) CHILDREN.
4. Youth Camp permit request dates are accepted on a first come, first served basis but will be not be accepted over 12 months before the reservation date(s) requested. Applications are accepted Monday through Friday, 8:30 AM to 4:00 PM.
5. Applications must be submitted in person for residents of San Diego County. For non-county residents, please contact the permit center at (619)235-1169 for further information and to receive an application via email. A MINIMUM OF 15 DAYS ADVANCE NOTICE IS REQUIRED PRIOR TO SUBMITTING YOUR CAMP DATE RESERVATION REQUEST.
6. Youth Camp Permits will be issued for 2 nights and 3 days. If you wish to camp for a longer period, please contact the Permit Center for further information.
7. You are required to contact the Park Ranger Office at (858) 581-7655, AT LEAST 15 DAYS PRIOR TO your ARRIVAL DATE to schedule your CHECK-IN appointment and obtain any additional information regarding your stay. FAILURE TO COMPLY MAY RESULT IN CANCELLATION OF YOUR YOUTH CAMP PERMIT.
8. CHECK-IN TIME: 3:00 pm – 4:00 pm. Contact the Park Ranger Office at (858) 581-7655. You must check in with a Park Ranger to ensure that the campsite is in good condition upon arrival and departure. Failure to do so may result in additional cleanup and/or repair charges.
9. ALCOHOL and GLASS containers of any kind are NOT permitted within the Youth Camp or anywhere in the beach and bay park areas. Animals are not permitted in the Youth Camp except for service dogs.

10. All vehicles must be unloaded and parked in the main parking lot. One vehicle per stall. Pull through stalls are available for vehicles with trailers attached. No vehicles may pull up to camp sites for unloading or park in red marked fire lanes. Fire roads and fire lanes must be kept clear at all times. Please be aware that this is strictly enforced and citations will be issued.
11. Water activities may be subject to separate restrictions.
CANCELLATIONS RESULTING FROM UNAVAILABILITY OF WATER USE WILL NOT BE REFUNDED.
12. The Youth Camp Permit must be on site and available for review upon request by Park Ranger Staff throughout your stay at the Youth Camp.
13. SLEEPING IN VEHICLES is not permitted within the Youth Camp and surrounding area. Recreational Vehicles or Trailers are not permitted within the Youth Camp – Only primitive tent and sleeping bag camping are permitted.
14. BOATS and/or PERSONAL WATERCRAFT are not permitted within the Youth Camp.
15. Do not move trash cans or other facilities from their assigned places, as this makes servicing difficult.
16. The Amphitheater is available on a first come, first served basis at no charge for campers or for a fee charged per day for non-campers. Check availability with the Permit Center.
17. GROUPS OF 250 OR MORE are required to provide 2 portable toilets. (1 of the toilets provided must be A.D.A. accessible), and groups are required to provide (one) 4-yard DUMPSTER WITH LID.
18. Fires are only permitted in the provided fire rings at each campsite.. If a portable barbeque is used, it must be placed in a location to avoid burning grass or landscaping. The coals must be extinguished after use and emptied into fire containers, permanent barbeques or taken home.
