# QUAIL BRUSH COMMUNITY PLAN AMENDMENT INITIATION – PROJECT NO. 270282

City Council District: 7 Plan Area: East Elliott

This is a request to initiate an amendment to the East Elliot Community Plan to redesignate a portion of a 22 acre parcel from open space to industrial. The site is located at 8506 1/3 Mast Blvd within the East Elliot Community Planning Area. Approval of this initiation request in no way confers adoption of a community plan amendment. Approval of this request would allow staff to fully analyze the proposal to develop a 100 megawatt intermediate/peaking load energy generation facility. A staff recommendation regarding the adoption of an amendment to the East Elliot Community Plan will be developed once the project has been fully analyzed.

The initiation of a community plan amendment is not a "project" under the definition set forth in CEQA Guidelines Section 15378. The California Energy Commission is the lead agency (for licensing thermal power plants 50 megawatts and larger) under the California Environmental Quality Act (CEQA) and has a certified regulatory program under CEQA. Under its certified program, the Energy Commission is exempt from having to prepare an environmental impact report. Its certified program, however, does require environmental analysis of the project, including an analysis of alternatives and mitigation measures to minimize any significant adverse effect the project may have on the environment. Environmental Analysis of the project would occur pursuant to the Energy Commission's certified regulatory program with either approval or denial of the initiation request. Report No. – PC-12-027
