SUMMARY

Issue – Should the Planning Commission approve an application for a Tentative Map to convert six residential units into condominiums and waive the requirement to underground the existing overhead utilities?

Staff Recommendations -

- 1. Approve Tentative Map No. 131656and
- 2. **Approve** a waiver to the requirement for the undergrounding of the existing overhead utilities

<u>Community Planning Group Recommendation</u> – On July 11, 2005, the Southeastern San Diego Planning Committee oted 61- 4to recommend app roval of the project without conditions (Attachment 10).

<u>Environmental Review</u> – This project is exempt from environmental review pursuant to Article 19, Section 15301 (k), Existing Facilities, of the California Environmental Quality Act (CEQA).

<u>Fiscal Impact</u> – None with this action. All costs associated with the processing of this application are paid for by the applicant.

Code Enforcement Impact - None with this action.

Housing Impact Statement – With the proposed conversion of the six existing apartments to condominiums, there will be a loss of six rental units and a gain of six for-sale units. This condominium conversion project was deemed completed on August 30, 2004 and is therefore subject to the new regulations regarding the inclusionary hosing and tenant relocation assistance.

BACKGROUND

The .10-acre site is located at 2248 Ocean View Boulevard, in the MF-2500 zone of the Southeastern San Diego Planned District of the Southeastern San Diego Community Planning area (Attachments1 and 2). The property is designated for residential use. The site is currently developed with one two-story buildings containing four units and one one-story building containing two units. The garage is located at the rear attached to the two story building. The project is surrounded by multi-family residential uses.

The building permit for this project was issued in 1968. The property was zoned C, a city-wide commercial zone, at he time of construction where six units were allowed by right. In 1968, the project was required to provide one on-site parking space for each residential unit. There are seven parking spaces on site, four spaces within the garage accessed from the alley and three surface spaces accessed from the Ocean View Boulevard. There is no Building or Zoning Code Violations have been recorded against this property.

DISCUSSION

Project Description:

The project proposes a Tentative Map for the subdivision of the .10-acre site and to convert six multi-family dwelling units into condominiums (Attachment 4). The applicant is also requesting that the requirement for the undergrounding of the existing overhead utilities be waived.

Section 125.0401 of the San Diego Municipal Code (SDMC) requires that a Tentative Map be processed for the subdivision of land. According to SDMC Sections 125.0440 and 125.0444, *Findings for tentative Map and Condo Conversions*, the decision maker may approve a Tentative Map for the conversion of residential units into condominiums if the decision maker finds that proposed project complies with the requirements of the Subdivision Map Act and the San Diego Municipal Code. Staff has reviewed the proposed project for condominium conversion and has determined that it complies with Subdivision Map Act and the San Diego Municipal Code.

Undergrounding Waiver Request

San Diego Municipal Code Section 144.0240 allows the subdivider to apply for a waiver for the requirement to underground the existing overhead utilities within the boundaries of the subdivision or within the abutting public right-of-way. Staff has determined that the undergrounding waiver request qualifies under the guidelines of Council Policy 600-25, *Underground Conversion of Utility Lines at the Developers Expense,* in that the conversion is a requirement for a condominium conversion of an existing development and the conversion would not represent a logical extension to an undergrounding facility. The applicant would be required to underground any new services to any new or proposed structure within the subdivision. The draft Tentative Map resolutions include general condition No. 4 to state this requirement (Attachment 3).

The power pole and overhead utility lines are located along the rear alley. The City's Undergrounding Master Plan for fiscal Year 2004 designates the site within Block 8-J, and the undergrounding allocation year is 2012 (Attachment 9). The undergrounding typically takes place one year from the date of the allocation.

Project Related Issues:

The requested conversion of these residential units to condominiums, represents primarily a change in ownership.

The applicant has certified that the required 60-Day Notice of Intent to Convert to Condominiums was provided to the tenants on April 28, 2004 (Attachment 8).

All condominium conversion projects Deemed Completed after February 7, 2004, must conform to the new regulations regarding the inclusionary housing and tenant relocation benefits adopted by City Council on March 15, 2004. This project was deemed completed on August 30, 2004, and is therefore subject to the new regulations. The project has been conditioned to require the applicant to pay an Inclusionary Affordable Housing In-Lieu Fee of \$3,888.5 pursuant to the Affordable Housing Requirements of the City's Inclusionary Housing Ordinance (Chapter 14, Article2, Division 13 of the Land Development Code); and demonstrate conformance with the Municipal Code provisions for the Tenant Relocation Benefits (Chapter 14, Article 4, Division 5), to the satisfaction of the City Manager and the Housing Commission, prior to the recordation of the Final Map.

CONCLUSION

Staff has reviewed the request for the Tentative Map for the conversion of the six residential units into condominiums and the request to waive the requirement for the undergrounding of overhead utilities, it was determined that the project is in conformance with the applicable sections of the San Diego Municipal Code regulating Tentative Maps and Council Policy 600-25 regulating undertgrounding of the existing overhead utilities. Staff believes that the required findings can be supported and recommends Planning Commission approves the proposed project.

ALTERNATIVES

- 1. **Approve** Tentative Map No. 131656 and the waiver to the requirement for the undergrounding of the existing overhead utilities, **with modifications**.
- 2. **Deny** Tentative Map No. 131656 and the waiver to the requirement for the undergrounding of the existing overhead utilities, **if the findings required to approve the project cannot be affirmed.**
