A mixture of 47 for-sale flats and townhomes, approximately 3,000 square feet of retail, and 5 rental apartments are proposed for construction.
- 3. <u>Collwood Project Update (Information Item)</u> The Dinerstein Companies are proposing to tear down the existing Collwood Pines Apartments and replace it with a 4-story, 261-unit apartment project. They are proposing to build a wrap design where the parking is above grade in a parking structure wrapped with the residential units. The proposed project complies with the College Area Community Plan as well as the City of San Diego General Plan.

# **Directions and Parking Instructions**

Free parking will be available in the basement of the SDSU Student Services East Building. Access is via Aztec Circle Drive, off of College Avenue heading south from Interstate 8. (From College Avenue going north, make a U-turn at the stoplight at the Alvarado Road/Canyon Crest Drive intersection and head south back up the hill on College Avenue.) Turn onto Aztec Circle Drive immediately after going under the new suspension pedestrian bridge by Aztec Center and the Transit Center (it is the third pedestrian bridge as you go up the hill). The street name is not marked; it will be the first right you can take after the stoplight at Alvarado Road/Canyon Crest Drive, and it is about a block before the stoplight at Lindo Paseo Drive and College Avenue. Aztec Circle Drive makes a sharp hairpin curve and goes around the back of Aztec Center. The next building on your left will be Student Services East, and a driveway will take you into the basement parking garage. Park in any SP 100 or SP 200 space. No permit will be required. Take the elevator up to the first floor. Take a right as you exit the elevator and follow the breezeway to Student Services West. At the very end of the breezeway, take a left. Go past the Registrar's Office. Student Activities and Campus Life, Room 1661, will be the last office on your left. (Note: The building directory is outdated and lists Room 1661 as Disabled Student Services, but the sign outside the office is correct.) The office faces Centennial Walkway and is on the south end of Student Services West, adjacent to Aztec Center, For a map, go to www.sdsu.edu/map and select Student Services from the alphabetical index. Please plan to arrive promptly at 7:00 p.m. since the office's lobby door automatically locks after office hours. The meeting will be in the conference room at the rear of the office. (If you arrive late, a phone number will be posted on the door for someone to come let you in.)
