PROPOSED MOTION: Support the proposed City of San Diego "Property Value Protection Ordinance". (The ordinance would create a registry of foreclosed properties, give a lender neglecting a vacant foreclosed property 30 days to maintain the property in compliance with City codes, and if the lender still fails to comply with City codes after 30 days, allow the City to fine the lender up to \$1,000 a day until the property is brought into compliance.)

Neighborhood Use Permit application (Process Two) for installation of a new wireless communication facility consisting of antennas located within a new tower structure and associated equipment. The subcommittee previously voted to recommend denial of the project at the March 7, 2011 meeting; however, the applicant has requested to present a new site design for additional consideration. The new site design modifications include: no changes to the existing church tower; the construction of a new 40' tower to contain the wireless communication facility; and the location of associated communications equipment in an adjacent storage room.

UDPR Motion: To deny proposed project because of incompatibility in bulk and scale with the neighborhood and with the community plan. Bonn/Granowitz 5-0-0

D. Fat Boys Corner Store - 3050 University Avenue (Project No. 241550): (8:10 pm)

Proposed Conditional Use Permit (CUP) for off-sale alcohol sales (ABC Type 21 liquor license) for a 1,200 square-foot neighborhood market in an existing 11,000 square-foot commercial building. The site is located within the CN-1 Zone of the Mid-City Communities Planned District. This project's CUP requires a Process Three, Hearing Officer decision (with appeal rights to the City's Planning Commission).

On January 21, 2011, the San Diego Police Department recommended denial of the application for a Type 21 liquor license because the location: is within a high crime area; is located within 100 feet of residences; and is located within 600 feet of incompatible uses. The applicant subsequently appealed the SDPD's denial. On April 5, 2011, the City's hearing officer overturned the SDPD's denial and granted the issuance of the Type 21 liquor license for the location. The SDPD continues to recommend denial of the CUP for the same reasons as stated on January 21, 2011. The owner has drafted additional conditions in response to the Subcommittee's action at the August 1, 2011 meeting. The additional conditions will be discussed for potential action.

UDPR Motion: To approve the CUP for Type 21 license with standard and supplemental conditions outlined in the Sept. 19 letter and a CUP with initial 2 year period with conditional 10 year extension. Granowitz/Nguyen 5-0-0

E. Jack in the Box Upas & 30th St This Item is being reheard at the request of applicant, to present an updated plan, including changes to the setback and all egress/ingress moved to Dale St, drive thru is still part of the project plan. (8:25 pm)

Background: NPPC heard the item on January 18, 2011, with the description and Motion included below:

A request for a Planned Development Permit (Project number 213093) on a 0.29-acre site located in the CN1-2 zone. The project applicant proposes to demolish the existing 1,944 sq. ft. restaurant and construct a new 2,491 sq. ft. restaurant with deviations to the current development regulations: 12 parking spaces where 37 are required; operation of a drive-thru where the CN1-2 zone does not allow such development; 24-hour operation of a drive-thru where the hours of operation are limited in the CN1-2 zone to 6:00am to 12:00 midnight. The decision to approve, conditionally approve, or deny the project will be made by the San Diego Planning Commission with appeal rights to the City Council (Process Four).

Item VIII B Foreclosures

BACKGROUND: This ordinance was introduced at the request of several community organizations including the Center on Policy Initiatives (CPI), a non-profit research and advocacy center focused on San Diego's working families. At the Sept. 14 meeting of the City Council's Land Use and Housing Committee (LU&H), the proposal was referred to the City Attorney's office to be drafted into ordinance language. The ordinance will return to LU&H on Oct. 26 and is tentatively scheduled to go to the full City Council on Nov. 14.

The ordinance is modeled on California state law, which specifically allows municipalities to enact such ordinances. Cities throughout California, including Chula Vista, have enacted similar ordinances in recent years as the foreclosure crisis has impacted their communities.

In North Park (92104), CPI projects that nearly two thousand homes (1,964) will have been foreclosed upon during the five-year period ending in 2012, an average of slightly over one foreclosure every day in North Park alone. Foreclosures often hurt more than the families foreclosed upon. If lenders fail to maintain vacant foreclosed properties and allow them to become blighted, the negative property value impacts can extend to the surrounding neighborhood. Cumulatively, neglected foreclosed properties can account for millions of dollars in lost property values to neighborhoods and municipalities.

This ordinance requires lenders to fulfill their responsibilities to maintain vacant properties they have foreclosed upon, and it creates a mechanism for the City to enforce this requirement.

The purpose of this community forum series, sponsored by the <u>University Heights Historical Society</u> and the <u>University Heights Community Development Corporation</u>, is to provide residents with a very broad overview of some of these recent changes, the basics of community planning in San Diego, and to invite residents to think about what they value about our neighborhood and their vision for its future shape.

NOVEMBER 10, 2011: *The Role of Community Organizations in Shaping University Heights*, Leo Wilson, Uptown Planners; Vicki Granowitz, North Park Planning Committee; Christopher Milnes, University Heights Community Development Corporation; and Greg Sorini, University Heights Community Association

Community members can have a voice in the shape of their communities by participating in a variety of organizations, including city-recognized planning groups and other organizations that participate in land use decisions. Representatives from key community organizations in UH will share a brief overview of their organization's mission, goals, membership and how to get involved.

JANUARY 12, 2012: What's So Special About University Heights? Defining Our Community Character, Kristin Harms, University Heights Historical Society

University Heights if one of San Diego' oldest and most historic communities, which is one of the top five reasons people like living here. Kristin will provide a brief overview of the early history of UH, changes in our community's demographic profile since 1980, and highlights of two recent surveys among UH residents about our quality of life and community character.

FEBRUARY 9: 2012: Community Planning: Balancing Individual Property Rights with Community Benefit, Barry Hager, Esq.

Extensive and precious as they are, our property rights have never been - and are not now - absolute. Like most other rights, property rights are tempered by responsibilities. The U.S. Constitution does not give property owners the right to abuse the land or to use their property in a way that hurts others. To be sure, land-use restrictions must advance a public purpose, be fairly and reasonably applied, and leave property owners with an economically viable use of their land. When these standards are met, however, land use regulations will pass legal muster. Sensible land-use laws almost always enhance, rather than depress, property values. Barry will discuss the constitutional framework for property rights and community benefit, and a local real estate agent will describe the impact of location and related factors on property value.

MARCH 8, 2012: Tools for Preserving Community Character: Historical Designation

The City of San Diego recognizes the benefits of historical resource preservation to the community as well as to individual property owners. In addition to protecting the unique history, architecture, or character of a community, preservation efforts promote a sense of neighborhood pride, and stabilize or increase property values. Cathy will discuss the benefits of historic designation, financial incentives for owners of historical properties, and the process for historically designating individual properties as well as districts.

APRIL 12: 2012: Tools for Preserving Community Character: Conservation Areas, Marlon Pangilinan

Conservation areas are a planning tool that can be used to help protect a neighborhood's unique community character through architectural guidelines, development standards, and special zoning provisions. The precise nature of each Conservation Area is generally determined by the residents of a particular neighborhood, in conjunction with the local Planning Group and the City. Used successfully in other cities, San Diego is contemplating use of Conservation Areas. Marlon will provide an overview of the background, purpose, and process for using Conservation Areas and how they might be used in University Heights.
